## FIRST AMENDMENT TO AGREEMENT FOR SERVICES OF INDEPENDENT CONTRACTOR FOR SHORT TERM BEDS FOR ADULT PROTECTIVE SERVICES

## First Amendment

This is a *First* Amendment (*First* Amendment to Agreement) to the Agreement for Services of Independent Contractor, number *BC#17-019* (Agreement) by and between the **County of Santa Barbara** (COUNTY) and **People Assisting the Homeless (PATH)**(CONTRACTOR), for the continued provision of Short Term Beds for Adult Protective Services (APS).

**WHEREAS**, on June 29, 2016, COUNTY approved the Agreement with CONTRACTOR for the provision of Short Term Beds for Adult Protective Services Clients; and

**WHEREAS**, the initial term of the Agreement commenced on July 1, 2016, and is set to expire on June 30, 2017, unless otherwise directed by COUNTY or unless earlier terminated; and

**WHEREAS**, the parties now desire to amend the Agreement to extend the term of the existing Agreement for one additional year commencing on July 1, 2017, through June 30, 2018 (Extension Period).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, COUNTY and CONTRACTOR agree as follows.

## The Agreement is amended as follows:

1. Section 4, TERM, of the Agreement, is amended by adding the following language:

For the Extension Period, CONTRACTOR shall commence performance on July 1, 2017 and end performance upon completion, but no later than June 30, 2018, unless otherwise directed by COUNTY or unless earlier terminated.

- 2. Section A of Exhibit B is amended to state in its entirety:
  - A. For CONTRACTOR services to be rendered under this Agreement, CONTRACTOR shall be paid a total contract amount, including cost reimbursements, not-to-exceed \$ **29,750** for the period of July 1, 2016 through June 30, 2017, and not-to-exceed \$10,000 for the Extension Period of July 1, 2017 through June 30, 2018.
- 3. In all other respects, the Agreement remains unchanged and in full effect.
