## **Recommended Actions:**

- a) Approve and authorize the Chair to execute the attached Statement of Final Quantities for construction of Rectangular Rapid Flashing Beacons; County Project No. 820796; First and Second Supervisorial Districts
- b) Determine that the approval of the Statements of Final Quantities is an administrative activity that will not result in direct or indirect physical changes in the environment, and is therefore exempt from the provisions of the California Environmental Quality Act pursuant to State CEQA Guidelines Section 15378(b)(5).

#### **Summary Text:**

This item is on the agenda to approve the Rectangular Rapid Flashing Beacons construction project as constructed and approve the attached Statement of Final Quantities. The Director of Public Works accepted this project as completed on June 19, 2024. This project was completed on time and on budget.

#### **Background:**

The Highway Safety Improvement Program (HSIP) is a core Federal-aid program with the purpose of achieving a significant reduction in traffic collisions and serious injuries on public roads through the installation of traffic control devices. A countywide study on uncontrolled marked crosswalks analyzed traffic collisions, crash potential, and crash rate. The study determined the locations that qualified for the HSIP program. The unincorporated areas of Isla Vista, Summerland, and Montecito contain uncontrolled

marked crosswalks with pedestrian warning signs. The project installed pedestrian actuated Rectangular Rapid Flashing Beacons to accompany the pedestrian warning signs. These flashing beacons enhance pedestrian conspicuity and increases driver awareness at uncontrolled marked crosswalks.

## Narrative:

The total construction cost, including contingencies amounts to \$265,911. Highway Safety Improvement Program will fund \$215,095 (80.89%) of the construction cost and RMRA will fund \$50,816 (19.11%) of the construction cost. Funds for this project were budgeted in Dept. 054, Fund 0016, Org Unit 0500, Program 2750, and Account 7510.
