That the Board of Supervisors:

- A. Accept a \$75,000 donation from the Orfalea Family Foundation designated for the Third Annual Spruce Up For Kids Day.
- B. Approve attached Budget Revision establishing revenue and appropriation accounts earmarked for Spruce Up For Kids Day program.

**Executive Summary and Discussion:**

The Orfalea Family Foundation was founded by Paul Orfalea, owner of Kinkos. The Foundation is a local charitable organization with a high interest in child care programs within the community. The Orfalea Family Foundation has recently donated to the Santa Barbara Children and Families Commission \$75,000 to match program funds for the Third Annual Spruce Up For Kids day. Through Spruce Up For Kids, local small and family based child care providers receive mini grants to help assist with improvements for their program. Last year, \$255,000 was awarded to 89 local child care programs.
