SUBJECT: Agreement with the State of California

for Fire Protection of State Responsibility Areas (CDF#7CA022005)

Recommendation(s):

That the Board of Supervisors: approve and execute an agreement with the State of California Department of Forestry and Fire Protection for fire protection services to state responsibility areas, period of July 1, 2002 through June 30, 2005 in the amount not to exceed \$13, 938,147.

Alignment with Board Strategic Plan:

The recommendation(s) are primarily aligned with Goal No. 2. A Safe and Healthy Community in Which to Live, Work, and Visit.

Executive Summary and Discussion:

This agreement between the County of Santa Barbara (Fire Department) and the State of California, Department of Forestry and Fire Protection (CDF) provides reimbursement to the County for costs associated with fire protection services to state responsibility areas for a 3-year period (July 1, 2002 through June 30, 2005). The agreement provides for payments by the State to Santa Barbara County in accordance with the amounts annually set forth in the State's budget each fiscal year, not to exceed \$13,938,147 during the term of this agreement.

This agreement is again for three years as negotiated and preferred by the contract counties and CDF.

Mandates and Service Levels:

No change in programs or service levels.

Fiscal and Facilities Impacts:

This three-year agreement exceeds the previous agreement by \$800,000. However, the entire \$14 million may not be realized since the actual revenue received during the three-year period covered by this agreement is dependent upon the final amounts allocated in the State's budget for each fiscal year. It is currently estimated that the 02/03 State budget will include approximately \$4.2 million for this contract. Monies to be deposited to Fund: 0001, Budget: 031, Account: 5730.
