# **Recommended Actions:**

That the Board of Supervisors:

Approve the Revised Proposition 1B Expenditure Plan for Fiscal Year 2007/08 Revenues in the amount of \$4,923,074.83.

### **Summary Text:**

The County of Santa Barbara is scheduled to receive \$4,923.074.83 in Proposition 1B revenues for fiscal year 2007/08. Before the County can acquire these funds from the State, the Board of Supervisors is required by the State to approve an expenditure plan for these funds. The funds are to be used to address transportation projects across the County. Following the guidelines set forth by the State Department of Finance and the State Controller's Office, the Public Works Department has assembled a list of priority transportation projects to expend the funds on over the remainder of fiscal year 2007/08 and fiscal year 2008/09. These projects are outlined in Attachment A for your review and approval.

The Department has three years to expend these funds after the fiscal year received; however, eligible expenditures cannot be accounted for until the County actually receives the funds from the State. It is vital to the financial health of the Road Fund that these funds are received as soon as possible and this action by your Board will allow that to occur.

#### Background:

In November of 2006, the voters of California approved Proposition 1B to fund a variety of transportation priorities across the state. As part of the 2007/08 Road Maintenance Annual Plan (RdMap), Proposition 1B funds were programmed for preventive maintenance projects; however, due to the delay in receiving these funds from the State and the financial challenges currently facing the Road Fund, it is necessary to reprioritize these funds at this time for the overall stability of the Road Fund. The Department will approach your Board in February as part of the CEO's Five Year Forecast item to discuss the reprioritization of work contained in the fiscal year 2007/08 RdMap and the financial challenges facing the Road Fund today and into the future.
