Recommendation(s):

That the Board of Supervisors:

- A. Accept Notice of Completion for work performed by the Contractor, Union Asphalt, Inc. (A local vendor) P. O. Box 1280, Santa Maria, CA 93456, and authorize Clerk to record.
- B. Review and approve the Statement of Final Quantities for work performed and materials supplied for this project by the Contractor, in the amount of \$1,437,829.22.

Alignment with Board Strategic Plan:

The recommendations are primarily aligned with Goal No. 1, An Efficient Government Able to Anticipate and Respond Effectively to the Needs of the Community.

Executive Summary and Discussion:

This project is part of the annual Preventive Maintenance Program of the Public Works Department. This project consisted of placing pavement reinforcing fabric and a Type B asphalt concrete overlay at various locations throughout Santa Barbara County. The Fourth District in Old Town Orcutt, the striping on Clark Avenue was reconfigured to allow for angled parking, also more crosswalks were added to allow pedestrians greater access. During the construction of this project approximately 25,000 tons of Asphalt Concrete was placed and approximately 28.8 lane miles of County maintained roadway was resurfaced.

Your Board approved the project as part of the 2003/2004 Capital Improvement Plan. The specific project locations were approved by your Board in the FY 2003/2004 Road Maintenance Annual Plan. (See Attachment A for a list of the completed street locations.)

The Director of Public Works accepted this project as complete on December 23, 2004. The project was completed on time and on budget.

Fiscal and Facilities Impacts:

The County's Measure "D" revenues in Department Budget 054/02/05, Fund 0015, Account 7511, Program 2900, and Organization Unit 0002 provided funding for this project.
