#### **Recommended Actions:**

Appoint members of special district board of directors in lieu of election of Board Members in Lieu of Election as if elected pursuant to Public Resources Code 9314.

#### **Summary Text:**

In 1986, Section 9314 of the Public Resources Code was amended to allow Resource Conservation Districts to request by resolution, that the Board of Supervisors appoints directors to the governing board of their district.

At the June 26, 2007 meeting, the County Board of Supervisors approved a resolution from the Cachuma Resource Conservation District requesting that the Board appoint the district's directors as provided for in Public Resources Code Section 9314. Pursuant to Section 9314, the resolution shall remain in effect until rescinded by the board of directors of the Cachuma Resource Conservation District, or until a petition requesting the rescission is received by the elections official.

On August 10, 2007, five candidates filed Declarations of Candidacy with the Santa Barbara County Elections Offices to fill the five expiring terms. Copies of each Declaration have been included for your consideration (see Attachment A). Each of the following candidates has met all qualifications for appointment to the Cachuma Resource Conservation District Board of Directors:
