RESOLUTION NO. 25-44

WHEREAS, the Board of Supervisors has received from the County Treasurer-Tax Collector, pursuant to Section 3698 and Section 3698.5 of California Revenue and Taxation Code, a Notice of Intention to Sell Tax-Defaulted Property and Request for Approval, stating: (a) his intention to make a sale under Chapter 7 of Part 6 of Division 1 of the California Revenue and Taxation Code and the type of sale; (b) a description of the property to be sold; and (c) the minimum price at which it is proposed to sell the property; and

WHEREAS, the Treasurer-Tax Collector has requested that the Board approve the sale of the tax-defaulted property(s) identified on Exhibit A at public auction via Internet for the stated minimum price. In the event that any parcel does not sell after the initial offering, the Treasurer-Tax Collector has also requested the Board's approval to re-offer those parcels at a reduced price during the public auction. The Treasurer-Tax Collector has further requested that the Board approve the re-offering of such parcel(s) at public auction via Internet within 90 days of the original sale date, with the option to offer the remaining parcels at a reduced minimum price;

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Santa Barbara, State of California, as follows:

1. That the Board hereby approves the sale by public auction via Internet, pursuant to Section 3694 of the California Revenue and Taxation Code, as set forth in said Notice of Intention to Sell Tax-Defaulted Property and Request for Approval. If any parcel does not sell after the initial offering, then those parcel(s) may be offered at a reduced minimum price, pursuant to Revenue and Taxation Code sections 3698.5(c) and 3698.7(c).
2. The Board further approves the re-offering of such parcels by public auction via Internet at a new sale within 90 days of the original sale date, pursuant to Revenue & Taxation Code section 3692(e), with the option to offer such parcels at a reduced minimum price, pursuant to Revenue & Taxation Code sections 3698.5(c) and 3698.7(c).

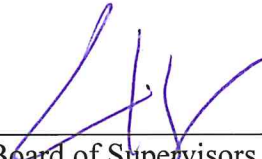

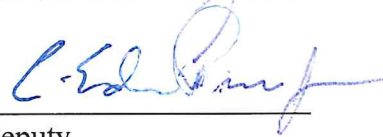
