Anapamu Street, 4<sup>th</sup> Floor, Santa Barbara, California, as the time, date and place for a hearing upon such Report; and

**WHEREAS**, the Clerk has caused notice of said hearing to be published pursuant to Section 6066 of the Government Code, and proof of such publication is on file with the Clerk; and

**WHEREAS**, three (3) copies of the notice of said hearing were posted in each of the zones in which assessments were proposed to be levied, as required by law, and proof of such posting is on file with the Clerk; and

**WHEREAS**, at the hearing this Board heard and considered all protests to the report, including protests with respect to the amount of the assessment to be levied, and then closed the public hearing; and

**WHEREAS**, at the conclusion of said hearing the Board made its determination upon each assessment described in the Report; and

**WHEREAS**, Section 54716 of the Government Code provides that at the conclusion of the hearing this Board may adopt, revise, change, reduce or modify any assessment and shall make its determination upon each assessment described in the Report and thereafter shall confirm the assessments by resolution;

**NOW, THEREFORE**, the Board of Directors of the Santa Barbara County Flood Control and Water Conservation District does hereby find and resolve as follows:
