#### **Report from Closed Session**

**County Counsel reported the following:** 

By a 5:0 vote the Board of Supervisors authorized County Counsel to sign the stipulation approved by the judge in the Santa Maria Groundwater Rights Litigation.

By a 5:0 vote the Board of Supervisors discussed in Closed Session participation in the appeal by Santa Ynez Valley citizens groups of the Bureau of Indian Affairs' decision to take 6.9 acres into trust for the Santa Ynez Band of Chumash Indians. On July 9, 2005, the Interior Board of Indian Appeals issued an order extending briefing on jurisdictional issues to August 11 and staying briefing on the merits of the appeal. In light of the new schedule, and considering the concerns of the County and the community and the stated desire of the Tribe to meet with Country leaders in an attempt to conclude and intergovernmental agreement regarding the use of the 6.9 acres, the Board of Supervisors agreed to a meeting between County and tribal leaders within the next two weeks.
