Justification: This budget revision will transfer appropriations in the amount of \$17,000 funded from a release of restricted fund balance to other financing uses to set up

operating transfers to the General Services general fund for the Public Health Department (PHD) specific share of a safety assessment by a consultant:

Mainstream Unlimited.

The PHD has chosen to add all of its facilities to a safety and security assessment of County facilities by a consultant managed by the General Services

Department. This budget revision will also transfer appropriations in the amount of \$2,000 from Social Services and \$3,100 from Behavioral Wellness for the

same study.
