Recommended Actions: That the Board of Supervisors:

- A. Authorize the County Executive Officer to sign the 2009 Byrne Justice Assistance Grant (JAG) Inter-local Agreements between the County of Santa Barbara and the Cities of Santa Barbara, Santa Maria and Lompoc.
- B. Authorize the Chief Probation Officer to sign the award agreements on behalf of Santa Barbara County and accept the anticipated 2009 Byrne JAG award in the amount of \$180,786 for the grant period October 1, 2008 through September 30, 2012.

Summary Text:

During the period covered by the JAG grant, Santa Barbara County will use the funds to continue to operate the Santa Barbara Regional Narcotic Enforcement Team (SBRNET), a multi-jurisdictional narcotic task force which targets major narcotic vendors operating in or trafficking through the County. The project will also focus on probation and parole cases with ties to narcotic use or sales, especially those with gang associations. By targeting these areas, the project will continue to positively impact the community by driving drug traffickers from Santa Barbara County; effectively decreasing violent crime.

Background: Santa Barbara County has received Edward Byrne Memorial Justice Assistance Grant (JAG) Program funding for 19 years. The JAG Program is a formula grant awarded to state and local governments. It is administered by the Department of Justice, Bureau of Justice Assistance. The grant supports a broad range of activities to prevent and control crime and to enhance the justice system. The procedure for allocating JAG funds is a formula based on population and crime statistics, in combination with a minimum allocation to ensure that each state and territory receives an appropriate share. The allocation favors high density municipalities and is corrected by a disparate funding allocation provision. In the 2009 allocations, Santa Barbara County is identified as a disparate jurisdiction. As such, a single joint application is required, as well as concurrence on the use of the funds by the County and the Cities of Santa Barbara, Santa Maria and Lompoc.

The County Law Enforcement Chiefs (CLEC) acting as the SBRNET Steering Committee have historically worked together to develop the allocation plan for these funds. The participating agencies have all reaffirmed their commitment to SBRNET's mission and agreed on an allocation plan that allowed all agencies to continue to deploy a staff member to the team. As part of the allocation plan, it was agreed that access to the full amount of agency grant funding would be predicated on the deployment of staff to SBRNET for the entire 12 months of the fiscal year, or subject to monthly proration. The City of Santa Maria was able to secure funding for their SBRNET staffing costs through other revenue. Although Santa Maria Police Department will be subject to the same agreement, the agency has elected to utilize their portion of the JAG funds to purchase a Cal-ID station to increase departmental effectiveness in pursuing criminal investigations.

As stated in previous Board Letters, SBRNET is a collaborative effort between all local law enforcement agencies to apply specific strategies designed to reduce the flow of narcotics through the County. The project uses searches, buy-bust operations and street sweeps as some of the tactics by which to accomplish the desired reduction of narcotic distribution in Santa Barbara County. The agencies involved in the project include the Santa Barbara County Probation Department, the Santa Barbara County District Attorney's Office, the Santa Barbara County Sheriff's Department, the Santa Barbara Police Department, the Lompoc Police Department, the Santa Maria Police Department, the Guadalupe Police Department, the State of California Highway Patrol Department and the State of California Department of Justice, Bureau of Narcotic Enforcement.

Performance Measure:

Over 25 project performance measures are tracked and reported to the Bureau of Justice Assistance. Along with investigative case-specific data, the following are a few of the key measures:

100% of children encountered at lab sites will be handled pursuant to the Santa Barbara County Drug Endangered Children (DEC) Protocol.

SBRNET will respond to and assist all local law enforcement agencies with the dismantling of methamphetamine labs as requested. In the course of this action, all Level I DEC cases will be addressed. Additionally, in the course of the service of search warrants, etc., where methamphetamine labs are not present, all determined Level II DEC cases will also be addressed per the Santa Barbara County DEC Protocol.

90 assists to local law enforcement on narcotic related activity will take place.

SBRNET will further the collaborative efforts between local law enforcement narcotic units and the multi-jurisdictional task force by responding to requests for assistance by local law enforcement units.

The goal in making the multi-jurisdictional task force available for this type of activity is to increase the flow of information and intelligence, as well as providing a substantive working relationship between the agencies and individual detectives.
