# Supervisors:

Please consider the health and safety impacts of the proposed development at 6737 Sueno in Isla Vista and other similar projects. Due to the existing, over capacity, number of cars in our community and the lack of pedestrian safety, this project and others of its size will create unsafe conditions for our citizens. As a long time resident, I navigate driving my car very slowly as there are always people walking in the middle of the street, often on headphones with no regard for cars. Many areas have no sidewalks.

Currently, cars park in red zones, block driveways, and fire hydrants. Accidents have occurred when corners are blocked by cars parking illegally. My neighbor, one morning, asked to borrow my car to take her husband to the emergency room as her driveway was blocked by a car.

As others have said, this project could produce 70-100 additional cars on a block that has only 77 spaces and is already above capacity. Cars from the project's residents will materially increase risks to existing Isla Vista residents.

As you go forward in approving, denying or asking for project modifications of this and other projects, please keep in mind the geographical size of Isla Vista, 0.55 to 0.595 square miles. Adding a projected 900 new cars, 450 new bedrooms (including ADUs) to the existing community is unsustainable for the future of Isla Vista.

As a community with several points of beach access, high pedestrian street access, over capacity parking with limited ingress, egress access, it would be advisable for an environmental impact report before moving this or other projects forward. Safety for all residents of Isla Vista should be of the highest priority, not that of overdevelopment at the expense of our community.

I submit this letter in support of the Soutar family's Appeal. My wife Sandra and I became permanent homeowners in 1977, across the street from the proposed development. In 2018, I retired from UC Santa Barbara, after teaching for 40 years. During that time I served as Chair of the Department of Art, and as Associate Dean of the College of Creative Studies. I participated in numerous Long Range Development Plans for the university community, served on Chancellor Yang's Isla Vista Commission, and on the Design Review Committee. Then, as now, housing was always the most important issue raised by students, staff, faculty, and visitors. Isla Vista is unique in many ways, especially in the tidal nature of its population. It is the only California beach town whose population goes down in the summer. It's also been expensively occupied by police, National Guard, and riot squads to contend with thousands of people blocking every street, driveway, entrance, and exit. Any formal consideration of new housing must squarely address the full context of the problems of parking, and the health, safety, and reasonable transit of its occupants. The Soutar Appeal graphically illustrates the deficiencies of the Applicant's development plan, and it suggests a better way.

Citing SB-330, the Applicant's proposal asks for exemptions that far exceed current zoning limits. At the same time it avoids responsibility for the automobiles, and, unwittingly, the transportation safety of its occupants. SB-330 clearly allows the County to scale back new housing plans when its elected officers believe conditions are not safe. There is no objective standard to determine which conditions are safe, and which are not. But exemptions from conventional parking requirements will not make Sueno Road safer for anyone. These exemptions will compound and exacerbate existing transit difficulties, congest the streets unnecessarily, and increase traffic danger for everyone, including pedestrians, bicyclists, skateboarders, scooters, and automobiles. The streets of Isla Vista have always been dangerous. Most East-West streets, like Sueno, have continuous sidewalks only on one side of the street. Pedestrians are forced to walk in the street, sharing the road and its hazards with automobiles, motorcycles, scooters, bicycles, and skateboards. When there are no sidewalks, tenants with or without on-site parking take to the street. There are two categories for anyone who rides a bicycle in Isla Vista: those who have already been in or witnessed a horrible accident, and those who will be involved in one soon. Throughout the six decades I have lived here, everyday Isla Vista bicycle traffic infractions have been underreported, or unknown, to the authorities. Slowly, over the years, streets were widened, traffic lights installed, streets illuminated, sidewalks constructed, and traumatized residents counseled only after shocking violent incidents became publicly known from local, regional, and national news. Do we have to wait for the next infamous tragedy for the County, UCSB, and property developers to create a working partnership that provides community parking structures, installs sidewalks on both sides of every street, and efficiently regulates inconsiderate bicycles, scooters, and skateboards that never pause at intersections?

In four separate letters opposing this development, I asked for the creation of an ad-hoc Isla Vista Area Planning & Development committee, to represent all the major stakeholders and review the full impact of this proposal and many others soon to follow. Isla Vista desperately needs its own viable Area Development Plan that truly provides safe, appropriate, and accountable housing without compromising the health and safety of residents, visitors, service providers, pedestrians, and emergency teams. Isla Vista Master Plans were discussed and amended for decades but never formally materialized. The Isla Vista Redevelopment Agency prioritized safe and responsible planning, adequate parking, and alternative transit partnerships. But it, too, never became operative. Everyone knows Isla Vistans experience major parking problems already. In addition to its residents, many UCSB students park wherever they want, outsiders fill the streets on weekends, party-crashers come and go in cars when lured by social media to impromptu events. Crowd control always begins with people in the streets and the regulation of vehicles. We all want to reduce the number of illegally parked and driven vehicles. We have to address the reasons so many cars are on our streets in the first place. Emergency strategies for police, fire fighters, and first responders are always frustrated by traffic congestion. Under SB-330, the Board of Supervisors can use their own understanding of what is safe and what is not to reject housing plans. I urge you to scale back the unsafe 6737 proposal, and postpone approval until the current and long-term parking and transit issues for all new proposed housing structures are studied, discussed, and mitigated.

In that time I have seen the number of cars in Isla Vista greatly increase, while the number of parking spots has decreased. Garages have been converted into living spaces. Driveways are occupied by more cars than before; tenants now share double or triple rooms.
