That the Board of Supervisors:

- a) Approve and authorize the Chair to execute the attached Statement of Final Quantities for the 17STM1 Storm Damage on Orcutt Garey Road; County Project No. 862387, Fifth Supervisorial District for work performed and materials supplied by Specialty Construction, Inc., (a Tri-County vendor), 645 Clarion Court, San Luis Obispo, CA 93401, in the amount of \$271,709.96; and
- b) Determine that the project was found by your Board to be exempt from the provisions of California Environmental Quality Act pursuant State Guidelines Section 15301(c) on May 16, 2017, a Notice of Exemption was filed on that basis, and the proposed action is within the scope of the attached Notice of Exemption.

Summary Text:

This item is on the agenda to approve the project as constructed and the attached Statement of Final Quantities. The project is a storm disaster repair located 0.3 miles east of Dominion Road. The repairs consisted of replacing the 36" corrugated metal pipe culvert with a 48" double walled high density polyethylene pipe and reconstruction of the westbound lane, shoulder, and embankment fill.

On June 20, 2017, your Board awarded the above referenced construction contract to Specialty Construction Inc., and construction work began on July 24, 2017. The Director of Public Works accepted this project as complete on September 5, 2017. This project was completed on time and on budget.

This project was funded using General Funds for Disaster Recovery. Public Works is seeking reimbursement through the Federal Highway Administration (80%; \$217,368) and the California Office of Emergency Services (15%; \$40,757). The remaining 5% (\$13,585) will be paid by local funds from Dept.054, Fund 0016, Org Unit 0500, Account LI 7510.
