To the Board of Supervisors,

I have been made aware of Mr. Steve Pepe inaccurately representing himself as the voice of the Sta. Rita Hills Wine Alliance in his stance against the BID project that the Santa Barbara Vintners Association is trying to create for funding.

Mr. Pepe closed his winery before the pandemic, after leasing his vineyards to Kendall-Jackson. He really has no horse in this race, and his attacks on the BID in 2019 have deprived us of much-needed funds for developing our wine region. I don't know anyone in the region, as a former board member of the SRHWA, who is agreement with Mr. Pepe. We are surprised that he has decided to revive his fight against regional funding.

Alma Rosa Winery supports the BID as a way of funding the SBVA. Without it, our wine region will continue to lag behind the other wine regions of California, Oregon and indeed much of the world.

I spent 25 years in the wine industry primarily in Napa Valley and relocated to run Alma Rosa, founded by industry godfather Richard Sanford, in 2018. I have continually been surprised at the lack of funding this region lacks for important marketing efforts.

We are in support of Civitas receiving information to make a proposal on a BID for the SBVA.

Although he was polite and tried to be helpful, he could only give some advice on avoiding problems with lost payments in the future. It is not reasonable to assume that the error lies with the postal delivery. It is just as likely that my property tax payment was lost in the Treasury Department building somewhere along the line with the many handlers there. Yet, I am automatically assessed an excessive penalty with no recourse. Again, I ask the Supervisors to investigate this situation. How many of their constituents are unjustly fined for payments made in good faith where the failure to receive the timely payment is not the fault of the property owner? How many of those constituents are vulnerable seniors? This is local government. "There is nothing we can do," is not an acceptable position. Thank you for your attention to this matter.

First, you should know that this taxpayer-supported employee was outrageously rude and, quite literally, laughed at my situation. If the Board of Supervisors believes it is acceptable for County employees to treat citizens in this manner, voters should be aware that is your opinion of the worth of the people you are supposed to represent. Second, I would like to know who can apprise me of my legal rights here. No property owner should be penalized for the error of lost mail which most likely occurred in this County office.

We feel it is important to clarify that the opinion's voiced by Mr. Steven Pepe in the testimony referenced above are only his, as the owner of Clos Pepe Vineyard. Mr. Pepe is not authorized to speak on behalf of the Sta. Rita Hills Wine Alliance, and his opinion is not to be interpreted for our Alliance as a whole.

We feel it important to further clarify a specific inaccurate statement made by Mr. Pepe during public commentary. In such statement, Mr. Pepe asserted that the Santa Barbara County Vintners Association offered a share of the BID assessment to the Sta. Dear Santa Barbara County Board of Supervisors,

I urge you to deny this dangerous project as recommended by the Santa Barbara Planning Commission.

In addition to the significant and unavoidable risks of spills from trucking the oil, the purported benefit of producing oil from the offshore platforms and processing it on the Gaviota coast would bring with it unacceptable risks of offshore oil spills, air pollution and toxic fire and smoke risks that were not analyzed in the EIR, which focused narrowly on trucking impacts.

The recent oil spill off of Orange County underlines the severity of these risks. In addition, ExxonMobil's facilities were the largest sources of air pollution in the county and contained dangerous and toxic materials in an area that has burned by wildfire twice in the 6 years since the facilities have been shut down. We were fortunate that oil and dangerous gases were not present at the site during the recent Alisal fire, which burned onto ExxonMobil's property.

It is not just that the trucking routes are along sections of road with above average accident rates, there have been specific and recent instances of oil tankers on this route spilling oil into rivers and starting fires. In fact, on October 11 -- the same day as the Alisal fire -- an oil tanker crash near Orcutt caused a fire in Eucalyptus trees.

Thank you for denying this dangerous and unacceptable oil trucking project.
