

**SECOND AMENDMENT TO AGREEMENT FOR COOPERATIVE
DISPATCH SERVICES**

Between

SANTA BARBARA COUNTY FIRE PROTECTION DISTRICT

And

CARPINTERIA-SUMMERLAND FIRE PROTECTION DISTRICT

This Second Amendment to the Agreement to Provide Cooperative Dispatch Services (hereafter, "AMENDMENT") is made and entered into by and between the Santa Barbara County Fire Protection District (hereafter, "DISTRICT") and the Carpinteria-Summerland Fire Protection District (hereafter, "CARPINTERIA"), collectively referred to as the "Parties."

RECITALS

WHEREAS, the Parties entered into an Agreement for Cooperative Dispatch dated August 31, 2021 (hereafter, "AGREEMENT") to provide computerized dispatch services to CARPINTERIA. Dispatch services will include, but are not limited to, receiving CARPINTERIA calls for service via transferred 9-1-1, 10-digit, and other means; alerting and dispatching CARPINTERIA resources to incidents developing from calls for service; providing emergency medical dispatch (EMD) services to callers; providing incident support as required; providing system status management for coverage and move-up; compiling and securing data related to the dispatch processes for the planning and implementation of public safety communications under a new operational platform, utilizing updated technology and equipment to enhance emergency response capabilities;

WHEREAS, the Agreement was originally structured when the facility was in its inception phase with an unknown go-live date;

WHEREAS, the facility became operational and began dispatch services for CARPINTERIA on May 13th, 2025;

WHEREAS, the First Amendment regarding Tablet Command became effective on January 1, 2025;

WHEREAS, the Appendices have been updated to reflect actuals: A) Financial Calculations and B) Communications (original Appendix B- Communications and original Appendix C- Alerting & Mobile Computing);

WHEREAS, a new appendix was added to address possible variances in the distribution of calls: C) Call Distribution Variances;

NOW, THEREFORE, in consideration of the mutual covenants and conditions contained herein, the Parties agree to amend the AGREEMENT as follows:

1. All references to the Regional Fire Communications Facility (RFCF), shall now refer to the Regional Fire Communications Center (RFCC).

2. The language in Section IV – Term, subsection A. Initial Term is hereby amended as follows:

This Agreement shall commence on May 13th, 2025, and remain in force for five (5) years unless terminated under the provisions of Section V, Termination

3. The language in Section IX – Operating Systems, Subsection A-4. Alerting is hereby amended as follows:

The DISTRICT shall assign alert tone pairs for each unique CARPINTERIA unit. It is the responsibility of CARPINTERIA, at its expense, and before the date the RFCC commences live operations, to equip necessary locations, apparatus, and devices with the ability to receive the tones and convert them into useful alerting processes, including integration with existing systems.

4. The language in Section IX – Operating Systems, Subsection A-5. Mobile and Portable Radio Equipment is hereby amended as follows:

CARPINTERIA will, at its cost, purchase and maintain mobile and portable radios compatible with the District's network.

5. The language in Section IX – Operating Systems, Subsection B. Computer Aided Dispatch System (CAD) is hereby amended as follows:

The District will purchase and maintain a CAD platform with interfaces for existing supporting software including alerting, text/paging, ImageTrend, PulsePoint, Tablet Command, First Watch, and Intterra. CAD will be supported 24/7 with dedicated staff. The CAD system will have provisions for continuity of operations (COOP) and disaster recovery (DR). Any additional interfaces requested by CARPINTERIA for CARPINTERIA-specific operations shall be at CARPINTERIA's cost and may require amendments to the District's contracts regarding the CAD platform.

6. The language in Section IX – Operating Systems, Subsection C. Mobile Computers is hereby amended as follows:

CARPINTERIA shall install and maintain mobile broadband devices in each apparatus, ensuring compatibility with the Tablet Command application. The DISTRICT will provide access to CAD through a Tablet Command interface and cloud services, enabling units to receive incident information and update unit status in real time. CARPINTERIA agrees to adhere to all operating protocols for Tablet Command as established by the regional dispatch governing process.

APPENDIX A – FINANCIAL CALCULATIONS

I. START-UP COST

The DISTRICT shall bear full responsibility for the initial capital expenditures, equipment procurement, hiring, and training associated with establishing the RFCC. The DISTRICT will own, operate, and maintain complete authority over the dispatch center in cooperation with all Partners ("Partner" refers to any individual entity, and "Partners" refers collectively to all participating entities).

II. FISCAL YEAR

The RFCC's fiscal year begins on July 1st and ends on June 30th each year.

III. COST ALLOCATION

The cost distribution among RFCC Partners will utilize a mixed allocation method, consisting of equally shared fixed and operational expenses, indirect costs, and proportionally shared incident-count call-for-service expenses.

A. Equally Shared Fixed Costs

The following fixed operational expenses will be divided equally among all Partners:

B. Calls for Service Costs

Incident-count costs will be proportionally allocated based on the actual number of incidents dispatched within each Partner’s jurisdiction. The following expenses are incident-based and thus proportionally shared:

C. Indirect Cost

Indirect costs are those incurred by the DISTRICT to support the RFCC, such as Accounting, Human Resources, and Legal expenses. Partner agencies are charged for indirect costs at a rate of 5% of the total allocated expenses.

D. Incident Calculation Methodology

Incident counts will be tracked in real-time, and data will be made available to each Partner upon request or in conjunction with the quarterly billing statement. The calculation will focus solely on dispatches made to specific jurisdictions, independent of responding units or the number of calls or notifications received.

EMS incidents requiring ambulance services will have costs equally shared between the fire jurisdiction where the call originated and the ambulance provider. Incidents requiring only fire suppression services will be fully charged to the originating jurisdiction. Incidents only requiring an ambulance will be fully charged to the ambulance provider.

E. Modification of Allocation Formula

Any modifications to the cost allocation methodology must be mutually agreed upon by all Parties and formalized through an amendment to the Agreement.

F. Unplanned Capital Asset Charges

If unplanned Capital Asset Charges occur, the Partners will share the cost equally.

IV. BUDGET

The DISTRICT will be responsible for preparing the annual RFCC budget each fiscal year during December and January. A budget review and input meeting will be held annually with all Partner agencies in November. The purpose of this meeting is to solicit budgetary recommendations and adjustments from Partner agencies.

A final approved budget will be distributed electronically to all Partner agencies. The DISTRICT will actively seek grants and alternative funding opportunities to mitigate operational and capital expenditures.

Quarterly budget-to-actual financial statements will be provided:

- Q1: July - September (By October 20th)
- Q2: October - December (By January 20th)
- Q3: January - March (By April 20th)
- Q4: April - June (By July 20th)

A. Billing Quarterly

Billing statements, reflecting each Partner's share of equally shared costs and service call costs from the previous quarter, will be distributed by the 20th day of each subsequent quarter.

B. Payments

Each Partner must submit their respective payments quarterly by the following due dates:

- Q1 Payment Due: November 15th
- Q2 Payment Due: February 15th
- Q3 Payment Due: May 15th
- Q4 Payment Due: August 15th

C. Late Payments

Payments overdue by 60 days will incur a penalty of 1.5% of the overdue amount, with an additional 1.5% penalty applied for every subsequent 30-day period or portion thereof. Outstanding balances exceeding 120 days will constitute a breach of this Agreement.

APPENDIX B – COMMUNICATIONS

I. RADIO FREQUENCIES

The enclosed copy of Federal Communications Commission Radio Station Authorization for call sign **KMA578** is hereby incorporated in this appendix.

At the request of the District, CARPINTERIA shall permit the District to assume ownership of all FCC frequencies licensed to CARPINTERIA under call sign KMA578, providing all necessary approvals and assistance for the transfer. Until such time as the District formally requests this transfer, CARPINTERIA will maintain the license in good standing.

Notwithstanding the licensed owner, the frequencies shall be used exclusively within the District's Communication Plan to benefit the RFCC or Operational Area, and both parties shall ensure that the licenses remain current and valid for the entire duration of the Agreement. Furthermore, the frequencies shall not be loaned, transferred, or reassigned to any other entity without explicit consent.

Upon the District assuming ownership of the frequencies, if CARPINTERIA chooses to terminate the Agreement pursuant to Section V, the District shall facilitate the transfer of ownership of all FCC frequencies licensed under call sign KMA578 back to CARPINTERIA, providing all necessary approvals and assistance.

In the event that any frequencies under call sign KMA578 become surplus to the District's operational needs, the District shall notify CARPINTERIA no later than 90 days prior to license expiration and allow for their transfer back to CARPINTERIA, with all necessary approvals and assistance provided.

II. EQUIPMENT

CARPINTERIA shall procure and maintain all necessary equipment to receive dispatch services from the RFCC, including, but not limited to, mobile and portable radios, mobile computing devices, and fire station alerting systems. CARPINTERIA must ensure compatibility with RFCC-supported technologies, including, but not limited to, Central Square CAD, Zetron ACOM radio dispatch consoles, EF Johnson VHF conventional radio systems, Tablet Command, and RFCC two-tone alerting systems.

APPENDIX C – Call Distribution Variances

I. Background

The County Fire Protection District, in collaboration with the County Fire Chiefs, established a Regional Fire Communications Center (RFCC) to improve emergency response efficiency and effectiveness across the County. The RFCC operates under a “boundary drop” model, wherein the closest and most appropriate resource is dispatched. Responses outside of existing jurisdictional boundaries through established Mutual Aid and Automatic Aid agreements should not be interpreted as a transfer of jurisdictional responsibility.

Call distribution will be monitored quarterly and included with the quarterly invoice. The respective agencies agree to collaboratively address identified issues in a timely and equitable manner.

II. Commitment to Collaboration

Participating agencies are committed to a fair, sustainable, and cooperative emergency response system. RFCC agencies will engage in good-faith, data-informed discussions to identify and implement mutually agreeable solutions. Formal discussions will occur quarterly with resolutions negotiated directly at the Joint Executive Committee.

III. Resolution Mechanisms

The following resolution mechanisms may be considered, including but not limited to:

- **Service-Based Adjustments:** Revisions to response plans that rebalance call distribution (e.g., reassigning certain call types or modifying response areas).
- **Computer-Aided Dispatch (CAD) Modifications:** Refinement of CAD logic or dispatch protocols to support more equitable distribution of calls while maintaining response efficiency and service standards.

Each Partner must submit their respective payments quarterly by the following due dates:

- Q1 Payment Due: November 15th
- Q2 Payment Due: February 15th
- Q3 Payment Due: May 15th
- Q4 Payment Due: August 15th

C. Late Payments

Payments overdue by 60 days will incur a penalty of 1.5% of the overdue amount, with an additional 1.5% penalty applied for every subsequent 30-day period or portion thereof. Outstanding balances exceeding 120 days will constitute a breach of this Agreement.

APPENDIX B – COMMUNICATIONS

I. RADIO FREQUENCIES

The enclosed copies of Federal Communications Commission Radio Station Authorization for call signs **WQVZ352**, **WQNQ808**, and **WPUD994** are hereby incorporated in this appendix.

At the request of the District, MONTECITO shall permit the District to assume ownership of all FCC frequencies licensed to MONTECITO under call sign KMA578, providing all necessary approvals and assistance for the transfer. Until such time as the District formally requests this transfer, MONTECITO will maintain the licenses in good standing. Notwithstanding the licensed owner, the frequencies shall be used exclusively within the District's Communication Plan to benefit the RFCC or Operational Area, and both parties shall ensure that the licenses remain current and valid for the entire duration of the Agreement. Furthermore, the frequencies shall not be loaned, transferred, or reassigned to any other entity without explicit consent.

Upon the District assuming ownership of the frequencies, if MONTECITO chooses to terminate the Agreement pursuant to Section V, the District shall facilitate the transfer of ownership of all FCC frequencies licensed under call signs WQVZ352, WQNQ808, and WPUD994 back to MONTECITO, providing all necessary approvals and assistance.

In the event that any frequencies under call signs WQVZ352, WQNQ808, and WPUD994 become surplus to the District's operational needs, the District shall notify MONTECITO no later than 90 days prior to license expiration and allow for their transfer back to MONTECITO, with all necessary approvals and assistance provided.

II. EQUIPMENT

MONTECITO shall support and maintain its existing VHF legacy radio system (historically operated as MTO Command 11 and MTO Command 12) and all necessary infrastructure until both parties agree the MONTECITO system is no longer required for Fire Service and EMS communications within the Operational Area and to the RFCC. MONTECITO shall procure and maintain all necessary equipment to receive dispatch services from the RFCC, including, but not limited to, mobile and portable radios, mobile computing devices, and fire station alerting systems. MONTECITO must ensure compatibility with RFCC-supported technologies, including, but not limited to, Central Square CAD, Zetron ACOM radio dispatch consoles, EF Johnson VHF conventional radio systems, Tablet Command, and RFCC two-tone alerting systems.

APPENDIX C – Call Distribution Variances

I. Background

The County Fire Protection District, in collaboration with the County Fire Chiefs, established a Regional Fire Communications Center (RFCC) to improve emergency response efficiency and effectiveness across the County. The RFCC operates under a “boundary drop” model, wherein the closest and most appropriate resource is dispatched. Responses outside of existing jurisdictional boundaries through established Mutual Aid and Automatic Aid agreements should not be interpreted as a transfer of jurisdictional responsibility.

Call distribution will be monitored quarterly and included with the quarterly invoice. The respective agencies agree to collaboratively address identified issues in a timely and equitable manner.

II. Commitment to Collaboration

Participating agencies are committed to a fair, sustainable, and cooperative emergency response system. RFCC agencies will engage in good-faith, data-informed discussions to identify and implement mutually agreeable solutions. Formal discussions will occur quarterly with resolutions negotiated directly at the Joint Executive Committee.

III. Resolution Mechanisms

The following resolution mechanisms may be considered, including but not limited to:

- **Service-Based Adjustments:** Revisions to response plans that rebalance call distribution (e.g., reassigning certain call types or modifying response areas).
- **Computer-Aided Dispatch (CAD) Modifications:** Refinement of CAD logic or dispatch protocols to support more equitable distribution of calls while maintaining response efficiency and service standards.

**SECOND AMENDMENT TO AGREEMENT FOR COOPERATIVE
DISPATCH SERVICES**

**Between
SANTA BARBARA COUNTY FIRE PROTECTION DISTRICT
And
CITY OF SANTA BARBARA**

This Second Amendment to the Agreement to Provide Cooperative Dispatch Services (hereafter, "AMENDMENT") is made and entered into by and between the Santa Barbara County Fire Protection District (hereafter, "DISTRICT") and the City of Santa Barbara (hereafter, "CITY"), collectively referred to as the "Parties."

RECITALS

WHEREAS, the Parties entered into an Agreement for Cooperative Dispatch dated November 16, 2021 (hereafter, "AGREEMENT") to provide computerized dispatch services to CITY. Dispatch services will include, but are not limited to, receiving CITY calls for service via transferred 9-1-1, 10-digit, and other means; alerting and dispatching CITY resources to incidents developing from calls for service; providing emergency medical dispatch (EMD) services to callers; providing incident support as required; providing system status management for coverage and move-up; compiling and securing data related to the dispatch processes for the planning and implementation of public safety communications under a new operational platform, utilizing updated technology and equipment to enhance emergency response capabilities;

WHEREAS, the Agreement was originally structured when the facility was in its inception phase with an unknown go-live date;

WHEREAS, the facility went operational on May 13th, 2025;

WHEREAS the DISTRICT began dispatch services for the CITY on June 3rd, 2025;

WHEREAS, the First Amendment regarding Tablet Command became effective on January 1st, 2025;

WHEREAS, the Appendices have been updated to reflect actuals: A) Financial Calculations and B) Communications (original Appendix B- Communications and original Appendix C- Alerting & Mobile Computing);

WHEREAS, a new appendix was added to address call inequities: C) Potential Call Inequity;

NOW, THEREFORE, in consideration of the mutual covenants and conditions contained herein, the Parties agree to amend the AGREEMENT as follows:

1. All references to the Regional Fire Communications Facility (RFCF), shall now refer to the Regional Fire Communications Center (RFCC).

2. The language in Section IV – Term, subsection A. Initial Term is hereby amended as follows:

This Agreement shall commence on June 3rd, 2025, and remain in force for five (5) years unless terminated under the provisions of Section V, Termination.

3. The language in Section VIII – Operating Systems, subsection A-4. Alerting is hereby amended as follows:

The DISTRICT shall assign alert tone pairs for each unique CITY unit. It is the responsibility of CITY, at its expense, and before the date the RFCC commences live operations, to equip necessary locations, apparatus, and devices with the ability to receive the tones and convert them into useful alerting processes, including integration with existing systems.

4. The language in Section VIII – Operating Systems, subsection A-5. Mobile and Portable Radio Equipment is hereby amended as follows:

CITY will, at its cost, purchase and maintain mobile and portable radios compatible with the District's network.

5. The language in Section VIII – Operating Systems, subsection B. Computer Aided Dispatch System (CAD) is hereby amended as follows:

The District will purchase and maintain a CAD platform with interfaces for existing supporting software including alerting, text/paging, ImageTrend, PulsePoint, Tablet Command, First Watch, and Intterra. CAD will be supported 24/7 with dedicated staff. The CAD system will have provisions for continuity of operations (COOP) and disaster recovery (DR). Any additional interfaces requested by CITY for CITY-specific operations shall be at CITY's cost and may require amendments to the District's contracts regarding the CAD platform.

6. The language in Section VIII – Operating Systems, subsection C. Mobile Computers is hereby amended as follows:

CITY shall install and maintain mobile broadband devices in each apparatus, ensuring compatibility with the Tablet Command application. The DISTRICT will provide access to CAD through a Tablet Command interface and cloud services, enabling units to receive incident information and update unit status in real time. CITY agrees to adhere to all operating protocols for Tablet Command as established by the regional dispatch governing process.

APPENDIX A – FINANCIAL CALCULATIONS

I. START-UP COST

The DISTRICT shall bear full responsibility for the initial capital expenditures, equipment procurement, hiring, and training associated with establishing the RFCC. The DISTRICT will own, operate, and maintain complete authority over the dispatch center in cooperation with all Partners ("Partner" refers to any individual entity, and "Partners" refers collectively to all participating entities).

II. FISCAL YEAR

The RFCC's fiscal year begins on July 1st and ends on June 30th each year.

III. COST ALLOCATION

The cost distribution among RFCC Partners will utilize a mixed allocation method, consisting of equally shared fixed and operational expenses, indirect costs, and proportionally shared incident-count call-for-service expenses.

A. Equally Shared Fixed Costs

The following fixed operational expenses will be divided equally among all Partners:

B. Calls for Service Costs

Incident-count costs will be proportionally allocated based on the actual number of incidents dispatched within each Partner's jurisdiction. The following expenses are incident-based and thus proportionally shared:

C. Indirect Cost

Indirect costs are those incurred by the DISTRICT to support the RFCC, such as Accounting, Human Resources, and Legal expenses. Partner agencies are charged for indirect costs at a rate of 5% of the total allocated expenses.

D. Incident Calculation Methodology

Incident counts will be tracked in real-time, and data will be made available to each Partner upon request or in conjunction with the quarterly billing statement. The calculation will focus solely on dispatches made to specific jurisdictions, independent of responding units or the number of calls or notifications received.

EMS incidents requiring ambulance services will have costs equally shared between the fire jurisdiction where the call originated and the ambulance provider. Incidents requiring only fire suppression services will be fully charged to the originating jurisdiction. Incidents only requiring an ambulance will be fully charged to the ambulance provider.

E. Modification of Allocation Formula

Any modifications to the cost allocation methodology must be mutually agreed upon by all Parties and formalized through an amendment to the Agreement.

F. Unplanned Capital Asset Charges

If unplanned Capital Asset Charges occur, the Partners will share the cost equally.

IV. BUDGET

The DISTRICT will be responsible for preparing the annual RFCC budget each fiscal year during December and January. A budget review and input meeting will be held annually with all Partner agencies in November. The purpose of this meeting is to solicit budgetary recommendations and adjustments from Partner agencies.

A final approved budget will be distributed electronically to all Partner agencies. The DISTRICT will actively seek grants and alternative funding opportunities to mitigate operational and capital expenditures.

Quarterly budget-to-actual financial statements will be provided:

- Q1: July - September (By October 20th)
- Q2: October - December (By January 20th)
- Q3: January - March (By April 20th)
- Q4: April - June (By July 20th)

A. Billing Quarterly

Billing statements, reflecting each Partner's share of equally shared costs and service call costs from the previous quarter, will be distributed by the 20th day of each subsequent quarter.

B. Payments

Each Partner must submit their respective payments quarterly by the following due dates:

- Q1 Payment Due: November 15th
- Q2 Payment Due: February 15th
- Q3 Payment Due: May 15th
- Q4 Payment Due: August 15th

C. Late Payments

Payments overdue by 60 days will incur a penalty of 1.5% of the overdue amount, with an additional 1.5% penalty applied for every subsequent 30-day period or portion thereof. Outstanding balances exceeding 120 days will constitute a breach of this Agreement.

At the request of the District, the CITY shall permit the District to assume ownership of all FCC frequencies licensed to the CITY under the CALL SIGNS providing all necessary approvals and assistance for the transfer. Until such time as the District formally requests this transfer, the CITY will maintain the licenses in good standing. Notwithstanding the licensed owner, the frequencies shall be used exclusively within the District’s Communication Plan to benefit the RFCC or Operational Area, and both parties shall ensure that the licenses remain current and valid for the entire duration of the Agreement. Furthermore, the frequencies shall not be loaned, transferred, or reassigned to any other entity without explicit consent.

Upon the District assuming ownership of the frequencies, if the CITY chooses to terminate the Agreement pursuant to Section V, the District shall facilitate the transfer of ownership of all FCC frequencies licensed under the CALL SIGNS back to the CITY, providing all necessary approvals and assistance.

In the event that any frequencies under the CALL SIGNS become surplus to the District’s operational needs, the District shall notify the CITY no later than 90 days prior to license expiration and allow for their transfer back to the CITY, with all necessary approvals and assistance provided.

II. EQUIPMENT

The CITY shall support and maintain its existing VHF legacy radio system (historically operated as STB Command 2 and STB Command 3) and all necessary infrastructure until both parties agree the CITY system is no longer required for Fire Service and EMS communications within the Operational Area and to the RFCC. The CITY shall procure and maintain all necessary equipment to receive dispatch services from the RFCC, including, but not limited to, mobile and portable radios, mobile computing devices, and fire station alerting systems. The CITY must ensure compatibility with RFCC-supported technologies, including, but not limited to, Central Square CAD, Zetron ACOM radio dispatch consoles, EF Johnson VHF conventional radio systems, Tablet Command, and RFCC two-tone alerting systems.



APPENDIX C – Call Distribution Variances

I. Background

The County Fire Protection District, in collaboration with the County Fire Chiefs, established a Regional Fire Communications Center (RFCC) to improve emergency response efficiency and effectiveness across the County. The RFCC operates under a “boundary drop” model, wherein the closest and most appropriate resource is dispatched. Responses outside of existing jurisdictional boundaries through established Mutual Aid and Automatic Aid agreements should not be interpreted as a transfer of jurisdictional responsibility.

Call distribution will be monitored quarterly and included with the quarterly invoice. The respective agencies agree to collaboratively address identified issues in a timely and equitable manner.

II. Commitment to Collaboration

Participating agencies are committed to a fair, sustainable, and cooperative emergency response system. RFCC agencies will engage in good-faith, data-informed discussions to identify and implement mutually agreeable solutions. Formal discussions will occur quarterly with resolutions negotiated directly at the Joint Executive Committee.

III. Resolution Mechanisms

The following resolution mechanisms may be considered, including but not limited to:

- **Service-Based Adjustments:** Revisions to response plans that rebalance call distribution (e.g., reassigning certain call types or modifying response areas).
- **Computer-Aided Dispatch (CAD) Modifications:** Refinement of CAD logic or dispatch protocols to support more equitable distribution of calls while maintaining response efficiency and service standards.

SECOND AMENDMENT TO COOPERATIVE DISPATCH AGREEMENT
Between
SANTA BARBARA COUNTY FIRE PROTECTION DISTRICT
And
CITY OF LOMPOC

This Second Amendment to the Agreement for the Provision of Emergency Dispatch Services (hereafter, "AMENDMENT") is made and entered into by and between the Santa Barbara County Fire Protection District (hereafter, "District") and the City of Lompoc (hereafter, "City" or "Lompoc"), collectively referred to as the "Parties."

RECITALS

WHEREAS, the Parties entered into a Cooperative Dispatch Agreement dated November 22, 2021 (hereafter, "Agreement") to provide computerized emergency dispatch services to City;

WHEREAS, under the Agreement, dispatch services will include, but are not limited to, receiving City calls for service via transferred 9-1-1 calls, 10-digit calls, and other means; alerting and dispatching City resources to incidents developing from calls for service; providing emergency medical dispatch ("EMD") services to callers; providing incident support as required; providing system status management for coverage and move-up; compiling and securing data related to the dispatch processes for the planning and implementation of public safety communications under a new operational platform, utilizing updated technology and equipment to enhance emergency response capabilities;

WHEREAS, the Agreement was originally structured when the facility was in its inception phase with an unknown go-live date and it was contemplated by the Parties that the provision of services by the District to the City under the Agreement would not begin until the facility became operational;

WHEREAS, the Parties and the Agreement contemplated that it would have a term of five (5) years from the date that the facility became operational and services actually commenced and Section V of the Agreement specifically provided that neither Party shall terminate the Agreement for five (5) years from the date the facility commenced live regional operations, except as set forth in the Agreement's termination provisions;

WHEREAS, the facility became operational on May 13th, 2025, the District began dispatch services for the City on May 29th, 2025, and the Parties now desire to amend and update the term of the Agreement to reflect the actual date services began;

WHEREAS, the First Amendment regarding Tablet Command became effective on January 1st, 2025;

WHEREAS, the Parties also desire to update the Agreement Appendices A and B based on actual operations: A) Financial Calculations and B) Communications (original Appendix B-

Communications and original Appendix C- Alerting & Mobile Computing); and remove the original Appendix C;

WHEREAS, the Parties also desire to make certain other revisions to the Agreement needed for consistency with current operations; and

WHEREAS, a new Appendix C was added to address call variances: C) Call Distribution Variances. ; NOW, THEREFORE, in consideration of the mutual covenants and conditions contained herein, the Parties agree to amend the AGREEMENT as follows:

1. All references in the Agreement to the Regional Fire Communications Facility ("RFCF"), shall now refer to the Regional Fire Communications Center ("RFCC").
2. The language in Section IV – Term, subsection A. Initial Term is hereby amended as follows:

This Agreement shall commence on May 29th, 2025, and remain in force until June 30, 2030 unless terminated under the provisions of Section V, Termination

3. The language in Section VIII – Operating Systems, subsection A-4. Alerting is hereby amended as follows:

The DISTRICT shall assign alert tone pairs for each unique City unit. It is the responsibility of City, at its expense, and before the date the RFCC commences live operations, to equip necessary locations, apparatus, and devices with the ability to receive the tones and convert them into useful alerting processes, including integration with existing systems.

4. The language in Section VIII – Operating Systems, subsection A-5. Mobile and Portable Radio Equipment is hereby amended as follows:

City will, at its cost, purchase and maintain mobile and portable radios compatible with the District's network.

5. The language in Section VIII – Operating Systems, subsection B. Computer Aided Dispatch System (CAD) is hereby amended as follows:

The District will purchase and maintain a CAD platform with interfaces for existing supporting software including alerting, text/paging, ImageTrend, PulsePoint, Tablet Command, First Watch, and Intterra. CAD will be supported 24/7 with dedicated staff. The CAD system will have provisions for continuity of operations (COOP) and disaster recovery (DR). Any additional interfaces requested by City for City-specific operations shall be at City's cost and may require amendments to the District's contracts regarding the CAD platform.

6. The language in Section VIII – Operating Systems, subsection C. Mobile Computers is hereby amended as follows:

City shall install and maintain mobile broadband devices in each apparatus, ensuring compatibility with the Tablet Command application. The City will provide access to CAD through a Tablet Command interface and cloud services, enabling units to receive incident information and update unit status in real time. City agrees to adhere to all operating protocols for Tablet Command as established by the regional dispatch governing process.





APPENDIX A – FINANCIAL CALCULATIONS

I. START-UP COST

The DISTRICT shall bear full responsibility for the initial capital expenditures, equipment procurement, hiring, and training associated with establishing the RFCC. The DISTRICT will own, operate, and maintain complete authority over the dispatch center in cooperation with all Partners ("Partner" refers to any individual entity, and "Partners" refers collectively to all participating entities).

II. FISCAL YEAR

The RFCC's fiscal year begins on July 1st and ends on June 30th each year.

III. COST ALLOCATION

The cost distribution among RFCC Partners will utilize a mixed allocation method, consisting of equally shared fixed and operational expenses, indirect costs, and proportionally shared incident-count call-for-service expenses.

A. Equally Shared Fixed Costs

The following fixed operational expenses will be divided equally among all Partners:

B. Calls for Service Costs

Incident-count costs will be proportionally allocated based on the actual number of incidents dispatched within each Partner's jurisdiction. The following expenses are incident-based and thus proportionally shared:

C. Indirect Cost

Indirect costs are those incurred by the DISTRICT to support the RFCC, such as Accounting, Human Resources, and Legal expenses. Partner agencies are charged for indirect costs at a rate of 5% of the total allocated expenses.

D. Incident Calculation Methodology

Incident counts will be tracked in real-time, and data will be made available to each Partner upon request or in conjunction with the quarterly billing statement. The calculation will focus solely on dispatches made to specific jurisdictions, independent of responding units or the number of calls or notifications received.

EMS incidents requiring ambulance services will have costs equally shared between the fire jurisdiction where the call originated and the ambulance provider. Incidents requiring only fire suppression services will be fully charged to the originating jurisdiction. Incidents only requiring an ambulance will be fully charged to the ambulance provider.

E. Modification of Allocation Formula

Any modifications to the cost allocation methodology must be mutually agreed upon by all Parties and formalized through an amendment to the Agreement.

F. Unplanned Capital Asset Charges

If unplanned Capital Asset Charges occur, the Partners will share the cost equally.

IV. BUDGET

The DISTRICT will be responsible for preparing the annual RFCC budget each fiscal year during December and January. A budget review and input meeting will be held annually with all Partner agencies in November. The purpose of this meeting is to solicit budgetary recommendations and adjustments from Partner agencies.

A final approved budget will be distributed electronically to all Partner agencies. The DISTRICT will actively seek grants and alternative funding opportunities to mitigate operational and capital expenditures.

Quarterly budget-to-actual financial statements will be provided:

- Q1: July - September (By October 20th)
- Q2: October - December (By January 20th)
- Q3: January - March (By April 20th)
- Q4: April - June (By July 20th)

A. Billing Quarterly

Billing statements, reflecting each Partner's share of equally shared costs and service call costs from the previous quarter, will be distributed by the 20th day of each subsequent quarter.

B. Payments

Each Partner must submit their respective payments quarterly by the following due dates:

- Q1 Payment Due: November 15th
- Q2 Payment Due: February 15th
- Q3 Payment Due: May 15th
- Q4 Payment Due: August 15th

C. Late Payments

Payments overdue by 60 days will incur a penalty of 1.5% of the overdue amount, with an additional 1.5% penalty applied for every subsequent 30-day period or portion thereof. Outstanding balances exceeding 120 days will constitute a breach of this Agreement.

APPENDIX B – COMMUNICATIONS

I. RADIO FREQUENCIES

The enclosed copy of Federal Communications Commission Radio Station Authorization for call sign **KNIF944** is hereby incorporated in this appendix.

At the request of the District, LOMPOC shall permit the District to assume ownership of all FCC frequencies licensed to LOMPOC under call sign KMA578, providing all necessary approvals and assistance for the transfer. Until such time as the District formally requests this transfer, LOMPOC will maintain the licenses in good standing. Notwithstanding the licensed owner, the frequencies shall be used exclusively within the District's Communication Plan to benefit the RFCC or Operational Area, and both parties shall ensure that the licenses remain current and valid for the entire duration of the Agreement. Furthermore, the frequencies shall not be loaned, transferred, or reassigned to any other entity without explicit consent.

Upon the District assuming ownership of the frequencies, if LOMPOC chooses to terminate the Agreement pursuant to Section V, the District shall facilitate the transfer of ownership of all FCC frequencies licensed under call sign KNIF944 back to LOMPOC, providing all necessary approvals and assistance.

In the event that any frequencies under call sign KNIF944 become surplus to the District's operational needs, the District shall notify LOMPOC no later than 90 days prior to license expiration and allow for their transfer back to LOMPOC, with all necessary approvals and assistance provided.

II. EQUIPMENT







I. START-UP COST

The DISTRICT shall bear full responsibility for the initial capital expenditures, equipment procurement, hiring, and training associated with establishing the RFCC. The DISTRICT will own, operate, and maintain complete authority over the dispatch center in cooperation with all Partners ("Partner" refers to any individual entity, and "Partners" refers collectively to all participating entities).

II. FISCAL YEAR

The RFCC's fiscal year begins on July 1st and ends on June 30th each year.

III. COST ALLOCATION

The cost distribution among RFCC Partners will utilize a mixed allocation method, consisting of equally shared fixed and operational expenses, indirect costs, and proportionally shared incident-count call-for-service expenses.

C. Indirect Cost

Incident counts will be tracked in real-time, and data will be made available to each Partner upon request or in conjunction with the quarterly billing statement. The calculation will focus solely on dispatches made to specific jurisdictions, independent of responding units or the number of calls or notifications received.

EMS incidents requiring ambulance services will have costs equally shared between the fire jurisdiction where the call originated and the ambulance provider. Incidents requiring only fire suppression services will be fully charged to the originating jurisdiction. Incidents only requiring an ambulance will be fully charged to the ambulance provider.

E. Modification of Allocation Formula

Any modifications to the cost allocation methodology must be mutually agreed upon by all Parties and formalized through an amendment to the Agreement.

F. Unplanned Capital Asset Charges

If unplanned Capital Asset Charges occur, the Partners will share the cost equally.

A budget review and input meeting will be held annually with all Partner agencies in November. The purpose of this meeting is to solicit budgetary recommendations and adjustments from Partner agencies.

A final approved budget will be distributed electronically to all Partner agencies. The DISTRICT will actively seek grants and alternative funding opportunities to mitigate operational and capital expenditures.

A. Billing Quarterly

Billing statements, reflecting each Partner's share of equally shared costs and service call costs from the previous quarter, will be distributed by the 20th day of each subsequent quarter.

B. Payments

C. Indirect Cost

Indirect costs are those incurred by the DISTRICT to support the RFCC, such as Accounting, Human Resources, and Legal expenses. Partner agencies are charged for indirect costs at a rate of 5% of the total allocated expenses.

D. Incident Calculation Methodology

Incident counts will be tracked in real-time, and data will be made available to each Partner upon request or in conjunction with the quarterly billing statement. The calculation will focus solely on dispatches made to specific jurisdictions, independent of responding units or the number of calls or notifications received.

EMS incidents requiring ambulance services will have costs equally shared between the fire jurisdiction where the call originated and the ambulance provider. Incidents requiring only fire suppression services will be fully charged to the originating jurisdiction. Incidents only requiring an ambulance will be fully charged to the ambulance provider.

E. Modification of Allocation Formula

Any modifications to the cost allocation methodology must be mutually agreed upon by all Parties and formalized through an amendment to the Agreement.

F. Unplanned Capital Asset Charges

If unplanned Capital Asset Charges occur, the Partners will share the cost equally.

IV. BUDGET

The DISTRICT will be responsible for preparing the annual RFCC budget each fiscal year during December and January. A budget review and input meeting will be held annually with all Partner agencies in November. The purpose of this meeting is to solicit budgetary recommendations and adjustments from Partner agencies.

A final approved budget will be distributed electronically to all Partner agencies. The DISTRICT will actively seek grants and alternative funding opportunities to mitigate operational and capital expenditures.

Quarterly budget-to-actual financial statements will be provided:

- Q1: July - September (By October 20th)
- Q2: October - December (By January 20th)
- Q3: January - March (By April 20th)
- Q4: April - June (By July 20th)

A. Billing Quarterly

Billing statements, reflecting each Partner's share of equally shared costs and service call costs from the previous quarter, will be distributed by the 20th day of each subsequent quarter.

B. Payments

Each Partner must submit their respective payments quarterly by the following due dates:

- Q1 Payment Due: November 15th
- Q2 Payment Due: February 15th
- Q3 Payment Due: May 15th
- Q4 Payment Due: August 15th

C. Late Payments

Payments overdue by 60 days will incur a penalty of 1.5% of the overdue amount, with an additional 1.5% penalty applied for every subsequent 30-day period or portion thereof. Outstanding balances exceeding 120 days will constitute a breach of this Agreement.

APPENDIX B – COMMUNICATIONS

I. RADIO FREQUENCIES

The enclosed copies of Federal Communications Commission Radio Station Authorizations for call sign **KOQ893** and **WPYS352** are hereby incorporated in this appendix.

At the request of the District, the CITY shall permit the District to assume ownership of all FCC frequencies licensed to the CITY under call signs KOQ893 and WPYS352, providing all necessary approvals and assistance for the transfer. Until such time as the District formally requests this transfer, the CITY will maintain the licenses in good standing. Notwithstanding the licensed owner, the frequencies shall be used exclusively within the District's Communication Plan to benefit the RFCC or Operational Area, and both parties shall ensure that the licenses remain current and valid for the entire duration of the Agreement. Furthermore, the frequencies shall not be loaned, transferred, or reassigned to any other entity without explicit consent.

Upon the District assuming ownership of the frequencies, if the CITY chooses to terminate the Agreement pursuant to Section V, the District shall facilitate the transfer of ownership of all FCC frequencies licensed under call signs KOQ893 and WPYS352 back to the CITY, providing all necessary approvals and assistance.

In the event that any frequencies under call signs KOQ893 and WPYS352 become surplus to the District's operational needs, the District shall notify the CITY no later than 90 days prior to license expiration and allow for their transfer back to the CITY, with all necessary approvals and assistance provided.

II. EQUIPMENT

The CITY shall support and maintain its existing VHF legacy radio system (historically operated as SMR Command 2 and SMR Command 3) and all necessary infrastructure until both parties agree the CITY system is no longer required for Fire Service and EMS communications within the Operational Area and to the RFCC. The CITY shall procure and maintain all necessary equipment to receive dispatch services from the RFCC, including, but not limited to, mobile and portable radios, mobile computing devices, and fire station alerting systems. The CITY must ensure compatibility with RFCC-supported technologies, including, but not limited to, Central Square CAD, Zetron ACOM radio dispatch consoles, EF Johnson VHF conventional radio systems, Tablet Command, and RFCC two-tone alerting systems.

APPENDIX C – Call Distribution Variances

I. Background

The County Fire Protection District, in collaboration with the County Fire Chiefs, established a Regional Fire Communications Center (RFCC) to improve emergency response efficiency and effectiveness across the County. The RFCC operates under a “boundary drop” model, wherein the closest and most appropriate resource is dispatched. Responses outside of existing jurisdictional boundaries through established Mutual Aid and Automatic Aid agreements should not be interpreted as a transfer of jurisdictional responsibility.

Call distribution will be monitored quarterly and included with the quarterly invoice. The respective agencies agree to collaboratively address identified issues in a timely and equitable manner.

II. Commitment to Collaboration

Participating agencies are committed to a fair, sustainable, and cooperative emergency response system. RFCC agencies will engage in good-faith, data-informed discussions to identify and implement mutually agreeable solutions. Formal discussions will occur quarterly with resolutions negotiated directly at the Joint Executive Committee.

III. Resolution Mechanisms

The following resolution mechanisms may be considered, including but not limited to:

- **Service-Based Adjustments:** Revisions to response plans that rebalance call distribution (e.g., reassigning certain call types or modifying response areas).
- **Computer-Aided Dispatch (CAD) Modifications:** Refinement of CAD logic or dispatch protocols to support more equitable distribution of calls while maintaining response efficiency and service standards.
