- A. Approve and authorize the Chair to execute the Statement of Final Quantities for the Seismic Retrofit of the San Marcos Road Bridge (No. 51C-002) at Maria Ygnacia Creek in the Second Supervisorial District, Federal Project No. BRLSZD-5951(090), County Project No. 862275 for work performed and materials supplied by Brough Construction, Inc., in the amount of \$709,923.35; and
- B. Find that the proposed actions are administrative activities that do not constitute a "Project" within the meaning of CEQA, pursuant to 14 CCR 15378(b)(2), that the proposed actions are therefore exempt from CEQA, and approve the filing of Notice of Exemption and the Statement of Final Quantities, on that basis.

Summary Text:

This seismic retrofit project is located on San Marcos Road approximately 0.6 miles north of Cathedral Oaks Road. The project consisted of seismically retrofitting Bridge No. 51C-002 by reinforcing the bent anchors and girders, replacing the existing steel cross braces with larger, stronger braces, adding new steel elements to the existing steel cross braces, adding cable restrainers to girders, and installing cast-in-drilled-hole piles behind the abutment walls for lateral support.

Project funds are budgeted in Dept. 054, Fund 0017, Org. 0600, Program 2810, Account 7510.
