Executive Summary and Discussion:

In 1994 the Board of Supervisors approved the Public Works Department's annual road maintenance planning and project selection process. In the first RdMap, the Department quantified the needs for pavement resurfacing and bridge repair and replacement.

The FY 06/07 RdMap process is similar to the process used to create the prior RdMaps. The Road Maintenance Section, of the Public Works Department, is responsible for the repair and maintenance of the County transportation system. This system includes approximately 1667 lane miles of roadways and their adjacent bike paths, 110 major bridges and over 4100 culvert and drainage structures. The system also includes an estimated 15,000 street trees, curb, gutter and sidewalks (including curb ramps for the physically challenged), equestrian trails and traffic signals.
