Title: Establish Appropriations in Social Services Fund 0058 for the STEP Grant

Budget Action: Establish appropriations of \$188,780 in the Social Services Department in WIOA-WDB fund for Salaries and Benefits of \$36,350 and Services and Supplies of \$152,430

funded by unanticipated revenue from Intergovernmental Revenue-Federal by the California Department of Rehabilitation.

Justification: The County of Santa Barbara Workforce Development Board was awarded a one-time Student Training and Employment Program (STEP) grant in the amount of

\$188,780 to administer pre-vocational training and work experience services for Students with Disabilities (SWD) in Santa Barbara County. The Foundation for California Community Colleges, in coordination with the California Department of Rehabilitation, is the designated agency responsible for managing the federal funds allocated for the STEP grant. This budget adjustment increases appropriations for (1) Salaries and Benefits to cover the staff and administrative costs associated with administering the program, and (2) Services and Supplies to cover staff travel costs and costs of contracting with Goodwill of Ventura and Santa Barbara Counties to serve as STEP

program operator. There is no impact to the General Fund.
