**WHEREAS**, the Code of Santa Barbara County, California, Section 23-11, authorizes the Board of Supervisors of the County by Resolution, to designate portions of roads and highways under its jurisdiction as "No Parking" Zones; and

**WHEREAS,** it appears to be in the best interest of public safety that certain portions of County highways in Santa Barbara County be designated as "No Parking" Zones, in accordance with said Section;

**NOW THEREFORE, IT IS HEREBY RESOLVED AND ORDERED,** that the following locations in Santa Barbara County and under the jurisdiction of the Board of Supervisors of said County are hereby designated as "No Parking" Zones:

- On the west side of San Ysidro Road, from the centerline of State Route 192 to a point 223 feet north of the centerline of State Route 192.
- On the west side of San Ysidro Road, from a point 35 feet north of the centerline of Bolero Drive to a point 260 feet south of the centerline of Bolero Drive.
- On the east side of San Ysidro Road, from the centerline of State Route 192 to a point 148 feet north of the centerline of State Route 192.
- On the east side of San Ysidro Road, from a point 235 feet north of the centerline of State Route 192 to the centerline of Bolero Drive.
- On the east side of San Marcos Road, from a point 337 feet north of the centerline of Via Parva to a point 366 feet north of the centerline of Via Parva.
- On the north side of Trigo Road, from the centerline of Embarcadero Del Norte to 130 feet east of the centerline of Embarcadero Del Norte.
- On the west side of Bradley Road, from a point 142 feet north of the centerline of Patterson Road to a point 218 feet north of the centerline of Patterson Road.
- On the east side of Bradley Road, from the centerline of Patterson Road to a point 208 feet north of the centerline of Patterson Road.

- On the east side of Bradley Road, from a point 140 feet south of the centerline of Patterson Road to a point 197 feet south of the centerline of Patterson Road.
- On the north side of Patterson Road, from the centerline of Bradley Road to a point 152 feet west of the centerline of Bradley Road.
- On the south side of Patterson Road, from the centerline of Bradley Road to a point 160 feet west of the centerline of Bradley Road.
- On the north side of Patterson Road, from the centerline of Bradley Road to a point 159 feet east of the centerline of Bradley Road.
- On the south side of Patterson Road, from the centerline of Bradley Road to a point 160 feet east of the centerline of Bradley Road.

**IT IS FURTHER RESOLVED**, that the Santa Barbara County Director of Public Works or designee is hereby authorized and directed to designate said locations with appropriate markings and/or signposts as time and resources permit.
