Hearing on the request of the Planning and Development Department for the Montecito Planning Commission to receive and file the *2016 Comprehensive Plan Annual Progress Report*; determine that the Montecito Planning Commission's actions regarding the *2016 Comprehensive Plan Annual Progress Report* are not actions that qualify as a "project," pursuant to the State CEQA Guidelines Section 15378(b)(5); and authorize staff to provide the *2016 Comprehensive Plan Annual Progress Report* to the Board of Supervisors, Governor's Office of Planning and Research, California Department of Housing and Community Development, pursuant to Government Code 65400, and to the City of Santa Barbara pursuant to the Board of Supervisors' action to adopt the *Mission Canyon Community Plan* (April 1, 2014).

At the Montecito Planning Commission hearing of January 15, 2017, Commissioner Overall moved, seconded by Commissioner Senauer and carried by a vote of 4 to 0 (Keller absent) to:

1. Receive and file the *2016 Comprehensive Plan Annual Progress Report*, included as Attachment A of the staff report dated February 7, 2017;
2. Determine that the Montecito Planning Commission's actions regarding the *2016 Comprehensive Plan Annual Progress Report* are not subject to CEQA pursuant to CEQA Guidelines Sections 15060(c)(3) and 15378(b)(5) (Attachment B of the staff report dated February 7, 2017); and
3. Authorize staff to provide the *2016 Comprehensive Plan Annual Progress Report* to the Board of Supervisors, Governor's Office of Planning and Research, California Department of Housing and Community Development, and city of Santa Barbara.
