AMENDMENT No. 2 TO PROFESSIONAL SERVICES AGREEMENT FOR

SANTA MARIA JUVENILE HALL/COURT EXPANSION PROJECT SITE NO. G20411

PROJECT NO. 8614/8621

This Amendment to Agreement is entered into, by and between:

Ravatt Albrecht & Associates, Inc. hereinafter called "ARCHITECT"

and

The County of Santa Barbara, California hereinafter called "COUNTY"

WITNESSETH

WHEREAS, the parties hereto under the date of December 12, 2000, entered into an agreement for performance of Architectural Services, by ARCHITECT in connection with the Santa Maria Juvenile Hall/Court Expansion Project; and

WHEREAS, the parties hereto desire to amend the Agreement:

NOW THEREFORE, the parties hereto agree as follows:

- I. Article 3, Item A, Sentence 1 is hereby amended to read as follows:
 - A. <u>Fee</u>: The COUNTY will pay the ARCHITECT a lump sum fee of ONE MILLION ONE HUNDRED EIGHTY-EIGHT THOUSAND FIVE HUNDRED THIRTY-ONE DOLLARS AND 98/100 (\$1,188,531.98) for all work described in the Agreement and in Attachment A.
- II. Article 3, Item B, Sentence 1 is hereby amended to read as follows:
 - A. <u>Reimbursement</u>: In addition to the basic fee in Paragraph 3.A., the ARCHITECT shall be reimbursed only for indirect and reimbursable expenses specifically identified and listed with a cost in Attachment B and shall not be in excess of \$23,000.

| III. | Article 9 is hereby amended to read as follows: Term: The term of this Agreement shall commence on the 12 th day of December 2000. This Agreement shall terminate on September 30, 2004 unless terminated earlier as provided herein. | |
