WHEREAS, The Board of Supervisors, on June 16, 2009, adopted two Resolutions, Numbered 90-189 and 90-190, which established no parking zones respectively on Tunnel Road and San Roque Road, in the Mission Canyon Area; and

WHEREAS, the Resolution were originally adopted with the proviso that the would be rescinded when conditions change to warrant their removal; and

WHEREAS, the area infrastructure has been largely restored and traffic volumes have returned to normal since the Jesusita Fire; and

WHEREAS, the slopes have new vegetation and the rainy season is coming to a close, reducing the likelihood of slope failures in the vicinity; and

WHEREAS, trails in the area have been reopened to recreational hikers creating the need for parking along these roadways;

WHEREAS, for these reasons it is no longer necessary to retain no parking zones at these locations, therefore such Resolutions should be rescinded; and

NOW THEREFORE, IT IS HEREBY RESOLVED AND ORDERED, that Resolutions No. 90-189 and 90-190 establishing no parking zones on Tunnel Road and San Roque Road be rescinded in their entirety at the hereinafter described locations:

On the east side of Tunnel Road from Spyglass Ridge to Valencia Ave; and

On both sides of San Rorue Road within the County jurisdiction from a point 150 feet south of Jesusita Lane to a point 1650 feet south of Jesusita Lane

IT IS FURTHER RESOLVED, that the Santa Barbara County Director of Public Works or designee is hereby authorized and directed to remove appropriate markings and /or signage at said locations.
