The award of the construction contract in the amount of \$640,952.60 to the lowest responsible bidder, JJ Fisher Construction Inc., 2250 Mahoney Rd., Suite B, Santa Maria, CA 93455 This exemption considers all further administrative activities, including the Statement of Final Quantities for project close out. The proposed project is located in the unincorporated Isla Vista area of Third Supervisorial District of Santa Barbara County.


