

**RESOLUTION OF THE BOARD OF SUPERVISORS OF THE

WHEREAS, the Board of Supervisors on April 9, 1984 adopted Resolution No. 84-137 which established stop controls on Courtney Drive in the Mission Hills area, on May 11, 2004 adopted Resolution No. 04-126 which established parking restrictions on Rice Ranch Road in the Orcutt area, and on December 9, 2014 adopted Resolution No. 14-297 which established stop controls on Wellington Drive in the Orcutt area; and

WHEREAS, conditions have changed since these Resolutions were adopted and it is now in the best interest of the public to revise these stop controls and parking restrictions.

NOW THEREFORE, IT IS HEREBY RESOLVED AND ORDERED, Resolution 84-137 which established stop controls on Courtney Drive in the Mission Hills area, Resolution 04-126 which established parking restrictions on Rice Ranch Road in the Orcutt area, and the portion of Resolution 14-297 which established stop controls on Wellington Drive in the Orcutt area at the following locations is rescinded:

Stop Control

- Stop all traffic entering Courtney Drive between Lewis Drive and Burton Mesa Boulevard.
- Stop Wellington Drive at its intersection with Westminster Lane.

Parking Restrictions

- Establish a no parking zone on the south side of Rice Ranch Road from the centerline of Esplanada Avenue to a point 122 feet east of the centerline of Esplanada Avenue.

IT IS FURTHER RESOLVED that the Santa Barbara County Director of Public Works or designee is hereby authorized and directed to remove appropriate markings and/or signs at said locations as time and resources permit.
