WITH REFERENCE TO THE FOLLOWING:

- A. **WHEREAS**, on January 7, 1980, by Resolution No. 80-12, the Santa Barbara County Board of Supervisors adopted the Santa Barbara County Coastal Land Use Plan;
- B. **WHEREAS**, on July 19, 1982, by Ordinance No. 3312, the Board of Supervisors of the County of Santa Barbara adopted the Santa Barbara County Coastal Zoning Ordinance, Article II of Chapter 35, Zoning, of the Santa Barbara County Code;
- C. **WHEREAS**, the Board of Supervisors, having found it to be in the interest of the general community welfare, consistent with the County's Comprehensive Plan, Coastal Land Use Plan, the Article II Coastal Zoning Ordinance, the Santa Barbara County Code, the requirements of State planning and zoning law, and consistent with good zoning and planning practices, adopted the following amendment to the Santa Barbara County Local Coastal Program:
 - 1. On _____, 2025 the Board of Supervisors adopted Ordinance No. _____ (Case No. 24ORD-00002) (Exhibit 1), amending Article II, the Coastal Zoning Ordinance, of Chapter 35, Zoning, of the Santa Barbara County Code, a Comprehensive Plan Amendment (Case No. 24GPA-00002) (Exhibit 2), amending the Eastern Goleta Valley Community Plan, of the Santa Barbara County Coastal Land Use Plan, and the *Montecito Architectural Guidelines and Development Standards* (Exhibit 3) related to outdoor lighting, signs, and other miscellaneous changes.
- D. **WHEREAS**, the Board of Supervisors held a duly noticed public hearing, as required by Government Code Sections 65355 and 65856, on the amendments referenced above, at which the amendments were explained and comments invited from persons in attendance;
- E. **WHEREAS**, this amendment to the Local Coastal Program is consistent with the provisions of the Coastal Act of 1976, the Santa Barbara County Coastal Land Use Plan, the Comprehensive Plan, including all community and area plans, and the requirements of State planning and zoning laws as amended to this date; and
- F. **WHEREAS**, the Board of Supervisors now wishes to submit the amendments to the California Coastal Commission for certification.

NOW, THEREFORE, IT IS HEREBY RESOLVED as follows:

- 1. The above recitations are true and correct.
- 2. Pursuant to the provisions of Government Code Sections 65856 and 65857 and Public Resources Code Section 30514, the above described changes have been adopted as an amendment to the Santa Barbara County Local Coastal Program.

3. The Board of Supervisors certifies that these amendments are intended to be carried out in a manner fully in conformity with the California Coastal Act.
4. The Board of Supervisors directs the Planning and Development Department to submit this Local Coastal Program amendment to the California Coastal Commission for review and certification.
5. The Chair and the Clerk of this Board are hereby authorized and directed to sign and certify all documents and other materials in accordance with this Resolution to reflect the above described action by the Board of Supervisors.
