

**RESOLUTION OF THE BOARD OF SUPERVISORS OF THE

IN THE MATTER OF RESCINDING)
NO PARKING ZONES ON)
EL COLEGIO ROAD) **RESOLUTION NO. _____**
IN THE ISLA VISTA AREA;)
THIRD SUPERVISORIAL DISTRICT)

WHEREAS, the Code of Santa Barbara County, California, Section 23-11, as amended by Ordinance No. 1824, authorizes the Board of Supervisors of the County by Resolution, to designate portions of roads and highways under its jurisdiction as no parking zones; and

WHEREAS, conditions have changed since these resolutions were adopted and it is no longer necessary to retain no parking zones at these locations and such Resolutions should be rescinded; and

NOW THEREFORE, IT IS HEREBY RESOLVED AND ORDERED, that the following Resolutions establishing no parking zones on portions of El Colegio Road, be rescinded in their entirety at the hereinafter designated locations:

- **Resolution No. 71-272(1)**
On the south side of El Colegio from a point 440 feet easterly of the centerline of Camino Corto to the University of California, Santa Barbara entrance.
- **Resolution No. 75-228**
On the south side of El Colegio between the centerline of Storke Road and a point 260 feet east of the centerline of Storke Road.
- **Resolution No. 75-564(a)(b)**
On the north side of El Colegio between a point 440 feet east of the centerline of Camino Corto and the west boundary of the main campus of the University of California of Santa Barbara.

On the south side of El Colegio between a point 260 feet east of the centerline of Storke Road and a point 460 feet east of the centerline of Storke Road.
- **Resolution No. 75-917(b)**
On the north side of El Colegio between the centerline of Storke Road and a point 90 feet east of the centerline of Storke Road.
- **Resolution No. 76-224(b)**
On the south side of El Colegio between a point 460 feet east of the centerline of Storke Road and a point 440 feet east of the centerline of Camino Corto.

- **Resolution No. 87-520(a)**
On the north side of El Colegio between a point 90 feet east of the centerline of Camino Corto and a point 48 feet west of the centerline of Camino Corto.
- **Resolution No. 91-329**
On the north side of El Colegio between a point 525 feet east of the centerline of Storke Road and a point 669 feet east of the centerline of Storke Road.
- **Resolution No. 05-352**
On the north side of El Colegio Road from a point 90 feet east of the centerline of Storke Road to a point 525 feet east of the centerline of Storke Road.

IT IS FURTHER RESOLVED, that the Santa Barbara County Director of Public Works or designee is hereby authorized and directed to designate said locations with appropriate markings and/or signposts as time and resources permit.
