

**RESOLUTION OF THE BOARD OF SUPERVISORS OF THE
COUNTY OF SANTA BARBARA, STATE OF CALIFORNIA**

**IN THE MATTER OF ESTABLISHING)
STOP CONTROLS, PLAYGROUND)
SPEED LIMIT ZONES AND)
PARKING RESTRICTIONS)
ON VARIOUS COUNTY ROADS)
IN THE FIRST, SECOND, THIRD & FOURTH)
SUPERVISORIAL DISTRICTS)**

RESOLUTION NO. 19-137

WHEREAS, California Vehicle Code Sections 21354, 22357.1, 22507 and 22507.5 and the Code of Santa Barbara County, California, Section 23-1 and 23-11, authorize the Board of Supervisors of the County, to establish stop intersections, playground speed limit zones, or parking regulations on portions of roads and highways under its jurisdiction; and

WHEREAS, it is in the best interest of public safety that certain portions of County highways in Santa Barbara County be designated as stop intersections, playground speed limit zones and no stopping, standing, or parking zones, in accordance with said Sections;

NOW THEREFORE, IT IS HEREBY RESOLVED AND ORDERED, that the following locations in Santa Barbara County and under the jurisdiction of the Board of Supervisors of said County are hereby designated as stop intersections, playground zones, or no stopping, standing, or parking zones and that the Director of Public Works of the County of Santa Barbara is hereby authorized and directed to install and maintain appropriate pavement markings and signs at the following locations.

Stop Controls

- Stop Santa Clara Way at its intersection with Santa Isabel Lane

Playground Speed Limit Zones (from dawn to dusk)

- On Merida Drive from Berkeley Road to a point 220 feet north of Agana Drive.
- On Vereda Del Ciervo from a point 275 feet north of Vereda Leyenda to a point 605 feet north of Vereda Leyenda.
- On Vereda Leyenda from a point 250 feet north of Vereda Del Ciervo to a point 655 feet north of Vereda Del Ciervo.

No Stopping, Standing, or Parking Zones

- On the south side of Jameson Lane (South) from the centerline of Eucalyptus Lane to a point 68 feet east of the centerline of Eucalyptus Lane.
- On the south side of Jameson Lane (South) from a point 690 feet east of the centerline of Eucalyptus Lane to a point 1,277 feet east of the centerline of Eucalyptus Lane.
- On the south side of Jameson Lane (South) from a point 1,405 feet east of the centerline of Eucalyptus Lane to the centerline of Posilipo Lane.
- On the west side of Tunnel Road from a point 60 feet south of the centerline of Holly Road (Private) to a point 128 feet south of the centerline of Holly Road (Private).

- On the west side of Tunnel Road from the centerline of Montrose Place to the centerline of Mission Canyon Road.
- On the west side of Tunnel Road from a point 160 feet south of the centerline of Memory Lane (Private) to a point 220 feet south of the centerline of Memory Lane (Private).
- On the west side of Tunnel Road from a point 200 feet south of the centerline of Orange Grove Avenue (Private) to a point 430 feet south of the centerline of Orange Grove Avenue (Private).
- On the west side of Mission Canyon Road from the centerline of Las Canoas Road to a point 2,250 feet north of the centerline of Las Canoas Road.
- On the west side of Puente Drive from a point 75 feet north of the centerline of Los Feliz Drive to a point 66 feet south of the centerline of Los Feliz Drive.
- On the west side of Puente Drive from a point 115 feet north of the centerline of La Loma Way to a point 95 feet south of the centerline of La Loma Way.
- On both sides of Ashbrook Lane from the centerline of Stillwell Road to the centerline of Brittany Lane.

IT IS FURTHER RESOLVED that the Santa Barbara County Director of Public Works or designee is hereby authorized and directed to install appropriate markings and/or signs at said locations as time and resources permit.


