WHEREAS, the Code of Santa Barbara County, California, Section 23-11, authorizes the Board of Supervisors of the County by Resolution, to designate portions of roads and highways under its jurisdiction as no parking zones, time limited parking zones, or loading zones; and

WHEREAS, it is in the best interest of public safety that certain portions of County streets or highways in Santa Barbara County be designated as either no parking, time limited parking, or loading zones, in accordance with said section; and

NOW THEREFORE, IT IS HEREBY RESOLVED AND ORDERED, that the following locations in Santa Barbara County and under the jurisdiction of the Board of Supervisors of said County are hereby designated as:

## No Parking Zones

• On the east side of Riven Rock Road from the centerline of East Mountain Drive to a point 400 feet south of the centerline of East Mountain Drive.

## 15 Minute Time Limit Parking Zones (9:00 am to 6:00 pm excluding Sundays and Holidays)

- On the north side of Pardall Road from a point 172 feet east of the centerline of Embarcadero Del Norte to a point 219 feet east of the centerline of Embarcadero Del Norte.
- On the south side of Madrid Road from a point 144 feet east of the centerline of Embarcadero Del Norte to a point 172 feet east of the centerline of Embarcadero Del Norte.

## Commercial Loading Zone

• On the north side of Sabado Tarde from a point 32 feet west of the centerline of El Embarcadero to a point 99 feet west of the centerline of El Embarcadero.

IT IS FURTHER RESOLVED, that the Santa Barbara County Director of Public Works or designee is hereby authorized and directed to designate said locations with appropriate markings and/or signs as time and resources permit, and in accordance with County Code Chapter 23, Article I.
