This Third Amendment ("Amendment"), dated November 7, 2023 ("Effective Date"), is made and entered into by and between the County of Santa Barbara, a political subdivision of the State of California ("COUNTY"), and Friendship Adult Day Care Center, Inc., a California nonprofit public benefit corporation ("CONTRACTOR") and is made with reference to the following:

**Recitals**

WHEREAS:

1. COUNTY and CONTRACTOR entered into an Agreement ("AGREEMENT"), dated August 16, 2022, to carry out an Adult Day program ("Program"), as more specifically described in the Scope of Work attached as Exhibit A to the Agreement; and
2. On June 27, 2023, the parties hereto entered into a First Amendment to revise the Program budget by removing \$17,000 from the "Supply Costs" line item and adding \$17,000 to the new "Salaries and Benefits" line item; and
3. On July 12, 2023, the parties hereto entered into a Second Amendment to renew the AGREEMENT for FY2023 by extending the term of the AGREEMENT to June 30, 2024, and updating Exhibit B to include FY2023 funds; and
4. Exhibit B of the Second Amendment did not accurately reflect the revised budget as amended by the First Amendment; and
5. COUNTY and CONTRACTOR desire to amend the AGREEMENT to revise the budget attached hereto as Exhibit B to place all program funds in the "Salaries and Benefits" line item as was amended by the First Amendment.

NOW THEREFORE, CONTRACTOR and COUNTY agree to amend the AGREEMENT as follows:

1. Exhibit B, Budget, is hereby amended by replacing Exhibit B in its entirety with the Exhibit B attached hereto and incorporated herein by this reference.

Except as set forth herein, this THIRD AMENDMENT TO AGREEMENT shall not modify or change any of the provisions of the AGREEMENT, and the parties to the AGREEMENT shall continue to be bound by its provisions, as amended herein.

This Amendment may be executed in any number of counterparts and each of such counterparts shall for all purposes be deemed to be an original; and all such counterparts, or as many of them as the parties shall preserve undestroyed, shall together constitute one and the same instrument.
