Recommended Actions:

- a) Award the construction contract for the Via Rueda Interceptor Storm Drain Project in the amount of \$257,095.00 to the lowest responsible bidder Tierra Contracting (a local vendor), subject to the provisions of documents and certifications, as set forth in the plans and specification applicable to the project and as required by law;
- Authorize the Chair to execute the construction contract upon return of the contractor's executed contract documents, and the review and approval of the County Counsel, Auditor-Controller, and Risk Manager or their authorized representatives;
- c) Approve a contingency in the amount of \$25,354.75 for the above subject project; and
- d) Approve plans and specifications for the project.

Summary Text:

The Via Rueda Interceptor Storm Drain Project is located on Vieja Drive off of Puente Drive in the unincorporated area in Goleta. The project consists of constructing a 36" diameter storm drain above Via Rueda that will intercept storm flows from an unimproved portion of Vieja Drive right-of-way and convey the storm flows to Atascadero Creek.

On August 23, 2007, the Flood Control District received ten bids for the Via Rueda Interceptor Storm Drain Project. Tierra Contracting submitted the apparent lowest bid in the amount of \$257,095.00.

Background:

The existing drainage facilities above the Via Rueda neighborhood are inadequate for the neighborhood. This project will improve drainage and decrease flooding potential to the area.


