- A. Set a public hearing on the departmental agenda for May 11, 2010 to do the following:
 - 1. Introduce the first reading of an ordinance amending Ordinance No. 3130 to revise service charges, connection fees and other related fees for the Laguna County Sanitation District;
 - 2. Receive and file with the Clerk of the Board a fixed charge report for fiscal year 2010/2011;
 - 3. Accept the notice of exemption pursuant to Section 15273 (a) (1) (4) of the State Guidelines for Implementation of the California Environmental Quality Act (attached Exhibit 1);

Summary Text:

In order to provide the current level of service, adhere to the Board's Enterprise Fund Reserve Policy and comply with regulatory requirements, staff recommends a sewer rate increase of 6.0%. This action also addresses the connection fee (developer impact fee) and trunk line fees for next fiscal year. The proposed actions are consistent with the Board's policies, prior ordinances and agreements, and the long-range fiscal plan for the enterprise fund.

Background:

The Laguna County Sanitation District (LCSD), a dependent special district, provides sewer service to customers primarily within the Fourth Supervisorial District and is regulated by the Regional Water Quality Control Board (RWQCB) under Waste Discharge Requirements and Master Reclamation Permit Order 01-042. The service area includes the community of Orcutt, unincorporated areas of Santa Maria south and east of the Santa Maria Public Airport District, and a few parcels located within the city of Santa Maria.

Sewer rates fund operational, maintenance, and replacement costs for services related to collection, treatment, and discharge services of customer generated wastewater. Annual rate adjustments allow the District to equalize the impact of costs associated with plant maintenance, repairs and improvements related to regulatory requirements, replacement or upgrade schedules. For example, the most recent upgrade completed in 2004 modified the plant to reduce salt from the waste stream in order to comply with Regional Water Quality Control Board (RWQCB) Basin Plan objectives for the Santa Maria Groundwater Basin. Sewer charge rates were established to accommodate operation of these new facilities.

Currently, the plant has the ability to treat 3.7 millions gallons per day (mgd) and dispose of 2.4 mgd. The current daily flow is approximately 2.1 mgd. It should be noted that full build out of the OCP and other development to be served by LCSD will require treatment, discharge, and storage capacity expansions to accommodate a projected wastewater flow of 5.0 mgd. At a later date, staff will present to the Board findings of a Facilities and Financial a Master Plan intended to address the infrastructure and costs associated with expanding capacity to accommodate this anticipated growth.

Staff recommends the adoption of these actions in order to maintain the current service level of the plant and related facilities. This action further sets two hearing dates to consider the adoption of an ordinance to revise service charge, trunk line and connection (capacity impact) fees. Public noticing including a mailer to District customers in compliance with Article 13D of the California Constitution (Proposition 218) and newspaper publication in compliance with Government Code Section 6066 accompany this proposal.

Service Charge

Service charges are billed on the tax roll to users of District facilities. These costs are distributed across the various billing categories based on flow, biological and solids loading as well as by the type of

facility being served as described in Section 29-36 of the County Code. The billing categories include single-family residences, multiple-family residences, schools, and commercial establishments.

The proposed budget includes revenue to fund operational costs as well as minor capital projects, plant and sewer system maintenance and reserve fund requirements. The reserve fund is intended to reduce future debt service, invest in capital assets, and provide for working capital, contingency, and expansion requirements. The reserve fund complies with the County Enterprise Fund Reserve Policy adopted by the Board in June of 2007.

A common way to evaluate service charge rate structure is by reviewing the rate for single family residential (SFR) units. The proposed annual SFR rate of \$551.58 is an increase of \$32.11 per year, which equates to a monthly increase of \$2.68 and is a 6.2% increase over last years' rate. For comparison, the 2009 CPI was 7.5% for the national average of water and sewerage maintenance costs.

Therefore, the following rate structure shown in the table below is proposed for fiscal year 2010-2011:

Connection Fee

Connection fees are developer wastewater impact mitigation fees. Connection fees generate revenue from new customers to fund plant facility expansions, upgrades and major rehabilitations. These fees are used to ensure that new development pay a fair share of existing facilities and capacity improvements and are derived from costs of the anticipated capacity improvements associated with the aforementioned Facilities & Financial Master Plan. This plan is expected to be finalized later this year and updates the information presented in 2001 conceptual master plan. Because the base structure for determining the connection fee is expected to change, no adjustment to the existing connection fee is proposed. Therefore, the connection fee of \$4,862 per residential unit equivalent will remain.

Solomon Creek Trunk Line Fees

A trunk line fee is a developer impact mitigation fee pertaining to a specific part of the collection system. The Dutard-Solomon segment of the Solomon Creek trunk line was completed by the District in 2001. The fee is assessed to new customers that benefit from its use and replenishes District reserves, which are then available for other capital improvements. There is no change this trunk line fee of \$865 per residential unit equivalent due to no gain in the 2009 Construction Cost Index (CCI), as published by the *Engineering News Record* for the city of Los Angeles.

The Bradley-Solomon segment of the Solomon Creek trunk line was constructed by a private party developer in 2006. The revenue from this fee reimburses the developer subject to the terms of the reimbursement agreement executed by the Board on January 15, 2008. That agreement used the prime interest rate for annual adjustments which was 3.25% for 2009. The proposed Bradley–Solomon trunk line fees are shown in the table below:

Performance Measure:

This action will establish rates and fees intended to supply adequate revenues for the District's operations and capital expense needs.

Fiscal and Facilities Impacts:

The proposed rates and fees are included in the FY 2010/2011 operating budget. The attached amending ordinance will adjust existing service rates and fees as discussed above.

Fiscal Analysis:

The proposed service charge revenue represents the District's proposed operating budget for next year, which is a 6% increase over last year's proposed revenue as shown in the table below. Revenue from fees will depend upon the number of new connections.
