This project completed part of the Capital Maintenance listed in the FY 2023-24 Road Maintenance Annual Plan (RdMAP). The project location was in the Fourth District which included hardscape repairs and construction of new curb ramps at Country Hill and Woodmere Roads.

The 2023-24 South County Pavement Rehabilitation total construction costs, including contingencies and supplemental amounts to \$1,911,477.18, budgeted in Dept. 054, Fund 0016, Org Unit 0500, Program 2710, and LI Account 7510.

The 2023-24 North County Pavement Rehabilitation total construction costs, including contingencies and supplemental amounts to \$6,112,010.72 budgeted in Dept. 054, Fund 0016, Org Unit 0500, Program 2710, and LI Account 7510.

The 2023-24 North County Hardscape Repairs total construction costs, including contingencies and supplemental amounts to \$326,248.80, budgeted in Dept. 054, Fund 0016, Org Unit 0500, Program 2720, and LI Account 7510.
