Title: GS, Orcutt Library Appropriations for Environmental Study

Budget Action: Increase appropriations of \$500,000 in the General Services Capital Outlay fund for Capital Assets funded by an operating transfer from the General Fund. Increase

appropriations of \$500,000 in General County Program General Fund for Other Financing Uses funded by release of Committed Props 215/64 - Cannabis fund balance.

Justification: This budget revision request, once approved, will provide the additional funding needed for the Professional Services Agreement with UltraSystems Environmental, Inc.

This request allocates available one-time Cannabis Funding of \$500,000 earmarked in the General County Programs General Fund Committed Cannabis fund balance for the Orcutt Library project and will supplement the remaining General Fund allocation to fully fund the UltraSystems Environmental, Inc. Contract. This Agreement will

be budgeted and accounted for in the Capital Outlay Fund 0030 Project PRJ-000233.

Based on state standards, Orcutt's existing population requires a library facility of approximately 20,000 square feet, requiring an increase of approximately 15,000 square feet based on the existing branch size of 4,507 square feet. To address this deficit and meet future demand, in 2021, the General Services Department conducted a survey of the area for suitable properties and identified the Union Oil Building as one available location.
