RESOLUTION NO: 19-300

WHEREAS, the County of Santa Barbara District Attorney desires to undertake a certain project designated as the Human Trafficking Advocacy (HA) Program, to be funded in part from funds made available through the Governor's Office of Emergency Services (Cal OES); and

WHEREAS, the District Attorney was awarded grant funding from Cal OES for the HA Program, subject to Board approval, in the amount of \$150,000 for the grant period of January 1, 2019 through December 31, 2019

NOW, THEREFORE, BE IT RESOLVED that the District Attorney is authorized to accept and sign on behalf of the County of Santa Barbara the attached Grant Subaward for the HA Program, for the period of January 1, 2019 through December 31, 2019 in the amount of \$150,000.

BE IT FURTHER RESOLVED THAT IT IS AGREED that any liability arising out of the performance of this Grant Award Agreement, including civil court actions for damages, shall be the responsibility of the grant recipient and the authorizing agency. The State of California and Cal OES disclaim responsibility of any such liability.

BE IT FURTHER RESOLVED that the applicant agrees to provide all matching funds required for said project (including any amendment thereof) under the Program and the funding terms and conditions of Cal OES, and that any cash match will be appropriated as required.


BE IT FURTHER RESOVED that grant funds received hereunder shall not be used to supplant expenditures controlled by this body.


