Title: Planning & Development: FY 2025-26 Isla Vista In-Lieu Parking Fee Fund loan to IVCSD

Budget Action: Increase appropriations of \$300,000 in the Planning & Development Isla Vista In-Lieu Parking Fee Fund for Other Charges funded by a release of Restricted Purpose of

Fund Balance to fund a loan to the IV Comm Services District.

Justification: The Isla Vista In-Lieu Parking Fee Program was created under the Isla Vista Redevelopment Agency and is currently managed by the Planning & Development

Department. Developers paid into the fund for various parking-related programs, including parking enforcement. The fees collected into this fund have remained

untouched since the Program's inception with a current balance of \$447,100.

The funds from the Isla Vista In-Lieu Parking Fee fund (Fund 1416) are held in a trust by the Planning & Development Department. Planning & Development will transfer the funds out of the trust and make a one-time payment of \$300,000 to the Isla Vista Community Services District effective April 1, 2026. Isla Vista Community Services District repayment of the loan will occur by the end of fiscal year 2027-2028. Payment(s) will commence October 1, 2026 and be deposited back into Fund 1416 quarterly,

as combined revenue and accrued interest (at 3.58%).
