## **Summary Text:**

The Santa Barbara County Grand Jury distributed four reports entitled "A Death in Custody – Lessons Learned," "Every Death in Custody is a Failure," "A Vicious Cycle - Incarceration of the Severely Mentally Ill," and "Death on Electronic Monitored Home Release." Today, the Board will consider the proposed responses to the reports, adopt their preferred responses, and authorize the Board Chair to sign the response letters. The Board is required to respond in writing to the Presiding Judge of the Superior Court.

**Background:** A **Death in Custody** – **Lessons Learned:** In this report, the Grand Jury concluded that an individual died in a jail cell while suffering a mental health crisis. The Grand Jury believes the criminal justice and health care systems offered numerous opportunities to provide the individual with effective mental health crisis intervention; however, these opportunities were missed for preventable reasons. The Grand Jury also found that the Coroner and District Attorney investigations of the manner and cause of death of this individual failed to address whether the custody officers' restraint hold, and the individual's resistance to it caused the death.

The Board of Supervisors is named as a responder to Findings 1 and 2, and Recommendations 1, 2a, 2b, 3, 4b, 5, and 6. Refer to Attachment A for the County's responses. The Probation Department and Public Defender's Office have also collaborated in the response to Finding 5 and Recommendation 5.

**Every Death in Custody is a Failure:** In this report, the Grand Jury concluded that an individual with a history of arrests and mental health issues died in a jail cell. The Grand Jury believes the individual should have been contacted by a mental health professional and not been placed alone in a jail cell.

The Board of Supervisors is named as a responder to Findings 1 and 2, and Recommendations 1, 1b, and 2. Refer to Attachment B for the County's responses.

A Vicious Cycle - Incarceration of the Severely Mentally III: In this report, the Grand Jury concluded that "the Santa Barbara County community faces a monumental task of providing effective treatment options for the mentally ill in place of the arrest-jail-court-arrest cycle. For those with mental health challenges, including those diagnosed with severe mental illness, Santa Barbara County faces an enormous challenge to divert individuals into comprehensive community services."

The Board of Supervisors is named as a responder to Findings 2, 3, 4, and Recommendations 2, 3a, 3b, 4a, and 4b. Refer to Attachment C for the County's responses. The Public Defender's Office has also collaborated in the response to Recommendation 4a and 4b.

**Death on Electronic Monitored Home Release:** In this report, the Grand Jury concluded that "EM Home Release program participants will more likely succeed if they have a robust support system in place, especially for those who have substance abuse and mental health issues." The report suggested that the Santa Barbara County Sheriff's Office and the Santa Barbara County Probation Department could make better informed decisions if they had access to inmates medical and mental health records.

The Board of Supervisors is named as a responder to Finding 2b and Recommendations 2a and 2b. Refer to Attachment D for the County's responses.
