- A. Approve plans and specifications for Construction of 2006/2007 Measure 'D' and Proposition 42 Asphalt Concrete Overlay and Reconstruction in the 3rd, 4th and 5th Supervisorial Districts of Santa Barbara County, County Project No. 810528;
- B. Award the construction contract in the amount of \$1,754,086.05 to the lowest responsive bidder, Union Asphalt, Inc. (a local vendor), P.O. Box 1280, Santa Maria, CA 93456-1280, subject to the provisions of documents and certification as set forth in the plans specifications applicable to the project and as required by law;
- C. Authorize the Chair to execute the construction contract upon return of the Contractor's executed contract documents and the review and approval of the County Counsel, Auditor-Controller, Risk Manager or their authorized representatives; and
- D. Approve a contingency fund in the amount of \$100,204.30 for Construction of 2006/2007 Measure 'D' and Proposition 42 Asphalt Concrete Overlay and Reconstruction in the 3rd, 4th and 5th Supervisorial Districts of Santa Barbara County, County Project Number 810528.

Summary Text:

On Thursday, May 3rd, 2007, two (2) bids were opened for the Construction of 2006/2007 Measure ‘D’ and Proposition 42 Asphalt Concrete Overlay and Reconstruction in the 3rd, 4th and 5th Supervisorial Districts of Santa Barbara County, County Project Number 810528. The lowest responsive bid was submitted by Union Asphalt, Inc. (a local vendor), a California Corporation, in the amount of \$1,754,086.05, which is 32% under the Engineer’s Estimate. The low bid can be attributed to the proper timing of the project advertisement and the start of construction wherein there currently are minimal construction projects in the Northern Santa Barbara County and surrounding areas. Public Works staff has performed an analysis of the bid received and has determined that the bid is responsive and reasonable and recommends awarding this contract to Union Asphalt, Inc.

The proposed project is located in the unincorporated areas of Lompoc, Los Olivos, Mission Hills, Orcutt, Santa Maria, Guadalupe and Cuyama areas of the County of Santa Barbara and will resurface a total of 12.87 lane miles of roads. The construction will consist of the repairs of failed pavement areas and placement of a Type B asphalt concrete overlay over a pavement reinforcing fabric and asphalt concrete leveling course.

This project was bid in accordance with the Public Contract Code, which requires awarding to the lowest responsive bidder.



Background:

The Proposition 42 funded locations were approved by your Board on September 26, 2006 and are a part of the AB 2928 fund, which later became voter approved Proposition 42 signed by the Governor in 2001. The Measure ‘D’ funded project locations were approved by your Board in the FY 2006/07 Road Maintenance Annual Plan (RdMap) on March 28, 2006. The project locations are attached for your information.
