**Executive Summary and Discussion:** This trail dedication is required in conformance with the Parks, Recreation and Trails Map (PRT-2) of the Comprehensive Plan/Montecito Community Plan. TPM 14,510 is a subdivision of a parcel on East Valley Road (State Highway 192) which was approved by the Planning Commission on 8/15/01. The trail easement being dedicated represents a ten foot wide trail area adjacent to the CalTrans right-of-way running the length of the parcel along this narrow section of East Valley Road, and will provide additional road shoulder area for trail use.

The original Final Map is located in the Office of the County Surveyor
