Budget Action: Increase appropriations of \$312,000 in Community Services Department, Parks Division, Capital Projects Fund for Capital Assets funded by an operating transfer in from

the General Fund. Transfer appropriations of \$312,000 in Community Services Department, Parks Division, General Fund from Services & Supplies to Other Financing

Uses for an operating transfer out to the Parks Department Capital Projects Fund.

Justification: This budget revision is necessary to increase appropriations for project 8702. The Project removes and replaces approximately 2,000 feet of the pool loop water

distribution line, appurtenances, hydrants and interconnections from the Cachuma Lake main line to the pool area, and repaves approximately 37,000 sf of park roadway. The existing infrastructure at Cachuma Lake has been in place since the creation of the Cachuma Lake Recreation Area in the 1950's. The age and condition of the infrastructure necessitates the complete replacement of the existing waterline. These 18% maintenance funds will be combined with a \$333,000 Bureau of Reclamation

grant as well as \$350,000 in committed Parks Capital fund balance.
