SUBJECT: Speed Zones: San Ysidro Road; First Supervisorial District, Kellogg Avenue and Nogal

Drive; Second Supervisorial District, and Broadway; Fourth Supervisorial District.

RECOMMENDATIONS

C.A. Recommendation:

That the Board of Supervisors:

- A. Set a public hearing for **December 13, 2005** to consider introduction of an ordinance amending Chapter 23, Sections 23-15 through 23-15.6, of the Code of Santa Barbara County, pertaining to speed limits on a certain County Road described herein.
- B. Conduct a second hearing on **January 3, 2006** and adopt the attached ordinance, amending Chapter 23, Sections 23-15 through 23-15.6, of the Code of Santa Barbara County, pertaining to speed limits on the subject road described herein.

ALIGNMENT WITH BOARD STRATEGIC PLAN

The recommendations are primarily aligned with the following Goals: #2) Ensure the Public Health and Safety and Provide Essential Infrastructure, and #5) Maintain and Enhance the Quality of Life for all Residents.

EXECUTIVE SUMMARY & DISCUSSION

The California Vehicle Code requires that speed limits on roadways be established based on the findings of an Engineering and Traffic Survey. California law prohibits the use of radar speed enforcement along such roadways where the speed limit has not been set in accordance with the findings of this type of study within the last seven to ten years.

In accordance with the California Vehicle Code, the Public Works Department has prepared Traffic and Engineering Surveys for San Ysidro Road in the Montecito area, Kellogg Avenue and Nogal Drive in the Goleta area and Broadway in the Orcutt area. These surveys were performed based on requests by the public, with the exception of Broadway. Broadway was done by the recommendation of the Traffic Section.

The Traffic Engineering Committee reviewed the speed changes at their meeting on the September 14, 2005 and agreed with the Traffic Section's recommendations. The following is the Traffic Section's proposed speed limits:

All recommended changes would be enforceable by radar, in compliance with State law. As part of this Ordinance, all speed zones within the City of Goleta will be deleted from the County Code.

MANDATES & SERVICE LEVELS

No mandates or service levels are affected by these actions.

FACILITIES AND FISCAL IMPACT

Approximately \$2000.00 will be required to post signs and paint legends. Funding is available in the County Public Works Department Budget No. 054, Fund 0015, Program 2200, and Account No. 7121.
