Dear Chair Hart and Supervisors,

As a long-term resident and advocate for the community of Tepusquet, I encourage the Board to adopt Option 1 or 2 but am absolutely opposed to Option 3. I also support all who oppose Option 3, which includes a list of concerning items, such as hunting, shooting ranges, etc., that would impact on the safety of our communities. In addition, considering the fact that most Ag lands are located in extremely high-fire hazard regions (like Tepusquet), I would caution the Board to carefully consider appropriate land uses.

It is also concerning to me that I was completely unaware of the public workshops that Commissioner Parke held. I feel most of the public is unaware of this ordinance amendment. The Agricultural Commission was not provided with a specific list of proposed uses, which also presents a problem, considering the Board relies on them for important input. I would recommend that the Board continue this meeting to a future date, after the public has had ample time to review the issues and respond accordingly.

This speaks to ongoing concerns with the County's lack of transparency and failure to notify the greater community in a timely manner. I do not believe this was done intentionally but I have witnessed this happening numerous times, re the Cannabis regulation process. Please improve in this area.
