# FIRST AMENDMENT Effective July 1, 2016

This First Amendment to the Agreement for Services of Independent Contractor ("First Amendment") is made between the Santa Ynez Community Services District with an address at 1070 Faraday Street, Santa Ynez, CA 93460 (hereafter "Contractor") and the County of Santa Barbara, Public Health Department (hereinafter "County").

WHEREAS, the Agreement is effective through June 30, 2016; and

**WHEREAS**, the parties desire to amend the Agreement to extend the term;

**WHEREAS**, this First Amendment incorporates the terms and conditions set forth in the Agreement, approved by the County of Santa Barbara.

**NOW, THEREFORE**, in consideration of the mutual covenants and conditions contained herein, the parties agree as follows:

1. <u>Definitions.</u> Capitalized terms used in this First Amendment, to the extent not otherwise defined herein shall have the same meanings as in the Agreement.

### 2. **Amendments.**

- a. The Agreement is amended as follows:
  - 4. **TERM.** The term of this Agreement shall be for the period of July 1, 2016 through December 1, 2016.
- 3. <u>Counterparts.</u> This First Amendment may be executed in several counterparts, all of which taken together shall constitute a single agreement between the parties.
- 4. Ratifications. The terms and provisions set forth in this First Amendment shall modify and supersede all inconsistent terms and provisions set forth in the Agreement. The terms and provisions of the Agreement, as expressly modified and superseded by this First Amendment, are ratified and confirmed and shall continue in full force and effect, and shall continue to be legal, valid, binding and enforceable obligations of the parties.
