In accordance with section 19 (Termination) of the above-referenced Agreement, the County of Santa Barbara Department of Behavioral Wellness issues this notice to partially terminate the Agreement for convenience. The following Program will terminate as of June 30, 2025: Transitional Age Youth (TAY) New Heights Full Service Partnership (FSP) program countywide. The reason for the termination of this Program is ongoing staffing challenges and subsequent lack of referrals. The current multiyear contract will remain in effect through June 30, 2025.

Behavioral Wellness will seek the County of Santa Barbara Board of Supervisors approval of the partial termination of the Agreement on or around June 24, 2025. Contingent upon the Board's approval, the partial termination will be effective June 30, 2025. Instructions concerning the wind-down process will follow this notice.
