- A. Approve plans and specifications for Construction of 2002/2003 Measure 'D' South County Asphalt Concrete Overlay in the First and Second Supervisorial Districts, in Santa Barbara County, County Project No. 810493;
- B. Award the construction contract in the amount of \$852,980.00 to the lowest responsible bidder, Granite Construction Co, a California corporation (Not A Local Vendor), P.O. Box 50085, Watsonville, California 95077, subject to the provisions of documents and certification, as set forth in the plans and specifications applicable to the project and as required by law;
- C. Authorize the chair to execute the construction contract upon return of the Contractor's executed contract documents and the review and approval of the County Counsel, Auditor Controller and Risk Manager or their authorized representatives:

### Alignment with Board Strategic Plan:

The recommendation(s) are primarily aligned with Goal No. 1, An Efficient Government Able to Respond Effectively to the Needs of the Community.

## **Executive Summary and Discussion:**

On Thursday, February 21, 2003, five (5) bids were opened for the Construction of 2002/2003 South County Measure 'D' Asphalt Concrete Overlay in the First and Second Supervisorial Districts, in Santa Barbara County, County Project No. 810493. The lowest responsible bid was submitted by Granite Construction Company, a California corporation, in the amount of \$852,980.00, which was 8% above the Engineer's Estimate. Staff has performed an analysis of the bids received and has determined that the low bid is responsible and reasonable. Staff recommends awarding this contract to Granite Construction Company.

The project is one of the strategies the Department employs in its annual Preventive Maintenance Program and consists of the removal and repair of failed areas in the existing pavement, cold planing, pavement reinforcing fabric and placement of an Type B asphalt concrete overlay over a asphalt concrete leveling course. Approximately 8 lane miles of County maintained roadway will be resurfaced with construction of this project.

In fiscal year 2000/2001 and 2001/2002 the Department received a total of \$3,379,723.85 in AB 2928 revenues. These revenues are derived from fuel sales taxes collected and received by the State General Fund. These moneys were specifically designated for the purpose of road maintenance needs throughout the unincorporated areas of the County. To achieve the criteria on the funds discussed above, the Department proposes to utilize AB 2928 funds in the sum of \$852,980.00 for this asphalt concrete overlay contract previously programmed for Measure 'D' revenues. This process in turn allowed an equal amount of Measure 'D' revenue to be re-programmed into the Measure 'D' Program of Projects approved by your Board on May 7th, 2002.

Your Board approved the project as part of the 2002/2003 Capital Improvement Plan. The specific project locations are approved by your Board in the FY 2002/2003 Road Maintenance Annual Plan (RdMap) and attached for your information.

This project was bid in accordance with the Public Contract Code, which requires the award to the lowest responsible bidder.

AB 2928 funding for this project is budgeted in Fund 0015, Org Unit 0002, Program 2900, Department 054 and Account 7512.
