### **Recommendation(s):**

That the Board of Supervisors approve the professional services contract with Grady W. Williams, P.E. as Project Manager for the period August 1, 2002 through July 31, 2004. Each contract year amount, including all benefits, shall not exceed \$85,000 per 12-month period.

#### Alignment with Board Strategic Plan:

The recommendation is primarily aligned with Goal No. 2. Ensure the Public Health and Safety and Provide Essential Infrastructure.

### **Executive Summary and Discussion:**

In the second quarter of 2002, a project manager within the Office of the County Architect left the employ of the County to return to school. Since that time, the Office of the County Architect conducted recruitments to backfill the vacant position. We received 18 potential candidates from around the state. After narrowing the list to like candidates to fill the vacant position, we held personal interviews. While the three top candidates presented sharp interpersonal, technical and general skills, only one could be chosen. Mr. Grady W. Williams, a Professional Registered Engineer, is clearly the best fit given the types of capital improvement projects to be undertaken by the Office of the County Architect in the next five years. Mr. Williams has extensive experience in medium and large construction projects and will be a valuable addition to the County.
