

CERTIFICATE OF FACTS

[Elections Code section 10515(a)]

I, Donna Glass, declare as follows:

I am the District Manager for the San Antonio Basin Water District and make this declaration pursuant to subdivision (a) of section 10515 of the Elections Code.

By 5:00 p.m. on August 9, 2024, the 88th day before the general district election scheduled to be held on November 5, 2024, only three (3) people filed a declaration of candidacy for each of the three elective offices to be filled at that election, and a signed petition, requesting that the general District election be held, has not been presented to any District representative or officer.


