That the Board of Supervisors:

- a) Approve, ratify, and authorize the Chair to execute the Participation Agreement (PA) 11591-SB-QM-25_26, with California Mental Health Services Authority (CalMHSA) for the Quality Measures and Performance Improvement Program to meet Healthcare Effectiveness Data Information Sets (HEDIS) reporting requirements for Measurement Year (MY) 2023, for a maximum contract amount of \$0.00, from April 8, 2025 to December 31, 2025; and
- b) Approve, ratify and authorize the Chair to execute the Participation Agreement (PA) 10471-SB-QM-24/25, with the California Mental Health Services Authority (CalMHSA) for the Quality Measures and Performance Improvement Program to meet Healthcare Effectiveness Data and Information Sets (HEDIS) reporting requirements for Measurement Year (MY) 2024, for a maximum contract amount not to exceed \$30,000 from April 8, 2025 to December 31, 2025;
- c) Delegate to the Director of the Department of Behavioral Wellness or designee the authority to adjust Program timelines and technical requirements per Exhibit A of the Agreement and approve additional analysis of the Healthcare Effectiveness Data and Information Set (HEDIS) data per Exhibit B, all without altering the maximum agreement amount and without requiring the Board's approval of an amendment of the Agreement, subject to the Board's ability to rescind this delegated authority at any time; and

d) Determine that the above actions are government funding mechanisms or other government fiscal activities that do not involve any commitment to any specific project that may result in a potentially significant physical impact on the environment to and are therefore not a project under the California Environmental Quality Act (CEQA) pursuant to section 15378(b)(4) of the CEQA Guidelines.

Summary Text:

The above referenced items are on the agenda to request the Board of Supervisors (Board) to approve, ratify, and authorize the Chair to execute the Participation Agreement (PA) 11591-SB-QM-25-26 with the California Mental Health Services Authority (CalMHSA), from April 8, 2025 to December 31, 2025, to meet the Healthcare Effectiveness Data Information Sets (HEDIS) reporting requirements for Measurement Year (MY) 2023, for a maximum contract amount of \$0.00. There are no costs connected to this Agreement as the County of Santa Barbara has already completed payments to CalMHSA under the previous Agreement (BC 24-125).

Additionally, it is requested that the Board approve, ratify and authorize the Chair to execute the PA 10471-SB-QM-24/25 with CalMHSA for Quality Measures and Performance Improvement Program, including Healthcare Effectiveness Data and Information Sets (HEDIS) reporting requirements for Measurement Year (MY) 2024, for a maximum contract amount not to exceed \$30,000, from April 8, 2025 to December 31, 2025.

Background:

In 2014, the Board of Supervisors approved the County of Santa Barbara's membership in the California Mental Health Services Authority (CalMHSA). CalMHSA provides fiscal and administrative services for its members, including contract management, research and development, data management, maintenance of a research depository, technical assistance, capacity building, education, and training.

On August 27, 2024, the Board entered into an Agreement with CalMHSA to deliver services through the Quality Measures and Performance Improvement Program ("Program") (BC 24-125) for a fixed rate of \$25,000 and additional Healthcare Effectiveness Data and Informational Sets (HEDIS) for costs not to exceed \$5,000 over the fixed rate, for a maximum contract amount of \$30,000 from February 7, 2024 to December 31, 2024. That Agreement enabled BWell to meet the HEDIS reporting requirements for Measurement Year (MY) 2023.

CalMHSA utilizes the National Committee on Quality Assurance ("NCQA") proprietary measure specifications to provide BWell with the results of the analysis of Santa Barbara County's performance on the relevant measures. CalMHSA provides additional information to DHCS and/or the California External Quality Review Organization (CalEQRO) if requested by BWell. Additionally, CalMHSA hosts webinars to support Participants in orienting to HEDIS measurements and related performance improvement strategies.

CalMHSA utilizes data provided by BWell to calculate the five required Mental Health Plan measures and four required Drug Medi-Cal Organized Delivery System measures. BWell data includes eligibility, service, and claims data, including Medi-Cal Master Eligibility Files, Managed Care Plan claims data, pharmacy claims, Behavioral Health Plan claims and service data, and Fee for Service claims.

BWell now requests to execute a new PA (11591-SB-QM-25_26) with CalMHSA for the Quality Measures and Performance Improvement Program, including Healthcare Effectiveness Data and Information Sets (HEDIS) reporting requirements for Measurement Year (MY 2023) from April 8, 2025 through December 31, 2025. The original Agreement (BC 24-125) has terminated effective December 31, 2024. CalMHSA requests to execute this new Agreement in order to align the reporting

requirements from MY 2023 through December 31, 2025, for a maximum contract amount of \$0.00. No additional fees will be incurred by the County for this service as all payments of \$30,000 have been paid under the previously executed Agreement (BC 24-125).

Additionally, BWell requests to execute a new PA (10471-SB-QM-24/25) with CalMHSA for the Quality Measures and Performance Improvement Program, including Healthcare Effectiveness Data and Information Sets (HEDIS) reporting requirements for Measurement Year (MY) 2024 from April 8, 2025 through December 31, 2025, for a maximum contract amount of \$30,000, at a fixed rate.

Performance Measure:

CalMHSA facilitates the efficient use of resources for multiple public entities by providing group purchasing power, joint development of Requests for Proposal (RFPs) and contracts for services, reduced overhead costs through sharing of the expenses of administration and reporting, and shared research and strategies. CalMHSA's administration of this program will result in greater efficiency in the implementation of these mandated services for compliance with state and federal requirements.

Contract Renewals:

The County may withdraw from the Program upon six months' written notice to CalMHSA as a measure of reducing contract risks. CalMHSA has provided satisfactory reporting to ensure Santa Barbara County BWell maintained compliance with state and federal requirements.

The risk in these Agreements is if BWell does not enter into them, BWell might not be able to continue to meet data reporting requirements of the MHP and DMC-ODS measures. There is no financial risk in BWell paying CalMHSA for these services.

BWell will fund this CalMHSA service with 50%, or \$15,000, in Federal, Medi-Cal Quality Assurance-Utilization Review funding, and the other 50%, or \$15,000, in State funds, including Mental Health Services Act and Realignment Reporting. Healthcare outcome measures is considered a Quality Assurance activity in the County's Mental Health Plan agreement with the State, and there is a dedicated Federal revenue source to cover such activities.
