On December 18, 2009, the Orfelea Foundation awarded the Santa Barbara County Sheriff's Department a \$67,009 grant to enhance the existing Reverse 911 system in use at the Consolidated Dispatch Center. The existing system is over five years old and is limited as to the number of phones lines that can be attached as well as utilizing outdated software that cannot be upgraded.

The total cost of the upgrade is anticipated to be \$76,005. The difference between the Foundation grant and the project cost will come from the Sheriff's Asset Forfeiture account as this has a direct impact on the law enforcement needs of the community.
