## **Recommended Actions:**

That the Board of Supervisors:

- a) Approve, ratify and authorize the Chair to execute the agreement for Services of Independent Contractor to provide security patrol services with Triumph Protection Group to include the period of July 1, 2025 and September 22, 2025, in an amount not to exceed \$455,608.01; and
- b) Determine that the above actions are not a "project" and are exempt from California Environmental Quality Act ("CEQA") pursuant to section 15378(b)(5) of the CEQA guidelines because they are organization or administrative activities of government that will not result in direct or indirect physical changes to the environment.

#### **Summary Text:**

This item is before the Board to approve and authorize a contract for payment of invoices to Triumph Protection Group for Security Patrol Services, ensuring continuity of operations and compliance with procurement and fiscal policies for services and payments from July 1, 2025 to September 22, 2025.

#### **Discussion:**

Between July 1, 2025 and the Board's approval of the contract on September 22, 2025, Triumph Protection Group provided Security Services to County of Santa Barbara locations to ensure uninterrupted security coverage. A bridge contract was implemented and in place through September 30, 2025, however the services exceeded the amount of the contract.

Services provided after September 22, 2025 are covered by Board Contract (SCON-002744), ensuring protection of County facilities, staff and public.

### **Background:**

Triumph Protection Group has provided security services to the County since September 1, 2016, and was awarded a contract renewal after RFP in June of 2025.

The County of Santa Barbara has engaged Triumph Protection Group to provide ongoing Security Services in both North and South County. Due to the continuation of services pending formal contract approval, services were rendered prior to the full execution of the agreement.

The total amount of \$455,608.01 represents outstanding invoices for Security Services provided from July 1, 2025 to September 22, 2025. These services were necessary to provide risk mitigation and ensure the safety and protection of the County's property, staff and the public.
